**RESOLUTION NO. 2018-254**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING SATCHMO BLUES BAR AND GRILL, INC., TO SELL ALCOHOLIC BEVERAGES AT THE PLAZA LOCATED AT 60 MERRICK WAY BEGINNING ON THURSDAY, SEPTEMBER 27, 2018, THROUGH SUNDAY, SEPTEMBER 30, 2018 AND THURSDAY OCTOBER 4, 2018 THROUGH SUNDAY OCTOBER 7, 2018, DURING THE **"OKTOBERFEST EVENT"**, SUBJECT TO FLORIDA DEPARTMENT OF PROFESSIONAL REGULATION REQUIREMENTS.

**BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the City Commission does hereby grant permission to Satchmo Blues Bar and Grill, to celebrate **"OKTOBERFEST"** in Coral Gables and have the ability to serve alcoholic beverages during the celebration and is in compliance with the laws of the State of Florida.

**SECTION 2.** The **"OKTOBERFEST"** will take place beginning at 6:00 p.m. until 10:00 p.m. on Thursday September 27th and October 4th, on Friday, September 28th and October 5th beginning at 6:00 p.m. until 11:00 p.m., on Saturday, September 29th and October 6th beginning at 3:00 p.m. until 11:00 p.m., and on Sunday, September 30th and October 7th beginning at 2:00 p.m. until 8:00 p.m. National and local bands will perform. Music played outside will end at 11:00 p.m., on Thursday through Saturday, and will end at 8:00 p.m., on Sunday.

**SECTION 3.** That Satchmo Blues Bar and Grill is approved to keep the plaza event set-up in place from Monday, October 1st through Wednesday, October 3rd. This approval is within agreement that the three set-up days be deducted from the 24 total days event limit per the Special Events Committee guidelines and conditions.

**SECTION 4.** This request has been reviewed by the City's Special Events Committee

**SECTION 5.** That this resolution shall become effective upon the date of its passage and adoption herein.
