**RESOLUTION NO. 2025-**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE ACCEPTANCE OF AMENDMENT NO. 2 TO GRANT AGREEMENT NO. LPA0271 WITH THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION (DEP) IN THE AMOUNT OF \$500,000, PROVIDING FOR AN EXTENSION TO THE CORAL GABLES STORMWATER MASTER PLAN PROJECT FROM OCTOBER 2025 TO MARCH 2027; AUTHORIZING THE CITY MANAGER TO EXECUTE THE AMENDMENT TO THIS AGREEMENT WITH FDEP, FOR SAID FINANCIAL ASSISTANCE.

**WHEREAS**, the City of Coral Gables was awarded a competitive grant in the amount of \$500,000 from the Florida Department of Environmental Protection under Grant Agreement No. LPA0271, for the development of a comprehensive Stormwater Master Plan; and

**WHEREAS**, the total project cost is \$1,000,000, of which \$500,000 is from the grant and \$500,000 is the required matching funds from the City of Coral Gables; and

**WHEREAS**, Amendment No. 2 extends the grant agreement from October 2025 to March 2027; and

**WHEREAS**, the proposed Amendment No. 2 does not negatively impact the City's standing with the DEP.; and

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

**SECTION 2.** The City Commission does hereby authorize the acceptance of amendment no. 2 to the Grant Agreement No. LPA0271 with the Florida Department of Environmental Protection in the amount of \$500,000 for the Coral Gables Stormwater Master Plan Project.

**SECTION 3.** That the City Manager is authorized to execute this amendment, as well as any future amendments, or change orders to this agreement.

**SECTION 4.** That this resolution shall become effective upon the date of its passage and adoption herein.
