RESOLUTION NO. 2012-04

RESOLUTION TO AMEND THE FISCAL YEAR 2011-2012 ANNUAL BUDGET TO RECOGNIZE AS REVENUE A \$6,677.00 DRUG CONTROL AND SYSTEM IMPROVEMENT GRANT AWARD AND TO APPROPRIATE SUCH AMOUNT TO PURCHASE A DIGITAL VIDEO RECORDING SYSTEM FOR THE POLICE DEPARTMENT.

WHEREAS, the Coral Gables Police Department is the established local law enforcement agency for the provision of law enforcement services within the jurisdictional boundaries of the City of Coral Gables; and

WHEREAS, the State of Florida Department of Law Enforcement, through the Miami-Dade Office of Criminal Justice Grants, has approved funding the Coral Gables Police Department Record Improvement Grant in the amount of \$6,677.00 (Six Thousand, Six Hundred Seventy Seven Dollars); and

WHEREAS, the Coral Gables Police Department has identified the need to purchase a digital recording system for the interview room in the Criminal Investigation Division; and

WHEREAS, City Administration recommends amending the Fiscal Year 2011-2012 Annual Budget to recognize the \$6,677.00 (Six Thousand, Six Hundred Seventy Seven Dollars) grant award; and

WHEREAS, City Administration recommends appropriating the \$6,677.00 (Six Thousand, Six Hundred Seventy Seven Dollars) grant to expend the award in accordance with the grant agreement; and

WHEREAS, this Resolution will support the usage of the FY 2012 Drug Control and System Improvement Grant Program Award by the local governing body.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the Coral Gables Police Department is hereby supported in their purchase of a digital recording system. The State of Florida Department of Law Enforcement FY 2012 award will fund the Coral Gables Record Improvement Project to purchase a digital recording system for the Criminal Investigations Division in the amount of \$6,677.00 (Six Thousand, Six Hundred Seventy Seven Dollars).

SECTION 3. That the City Commission does hereby amend the Fiscal Year 2011-2012 Annual Budget to include an increase in revenues in the amount of \$6,677.00 (Six Thousand, Six Hundred Seventy Seven Dollars), and appropriating such funds to expend the award in accordance with the grant agreement.

SECTION 4. That this Resolution shall become effective upon the date of its passage and adoption herein.
