A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO EXTEND THE CITYWIDE TROLLEY OPERATION SERVICES RFP 2017.03.MS WITH MV TRANSPORTATION, INC., PURSUANT TO SECTION 2-764 OF THE PROCUREMENT CODE ENTITLED 'APPROVAL OF CHANGE ORDERS AND CONTRACT MOCIFICATIONS."

- **WHEREAS,** on October 3, 2017, a contract for Trolley Operation Services to MV Transportation, Inc., pursuant to Request for Proposals (RFP) 2017.03.MS was effective; and
- **WHEREAS**, the purpose of the contract is to provide trolley operation services throughout Coral Gables; and
- **WHEREAS**, in order to allow time for the completion of a new competitive solicitation process and a new contract executed, it is recommended that the Trolley Operation Services contract be extended on a month-to-month basis to allow for the continuation of services; and
- **WHEREAS**, Section 2-585 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts; and
- WHEREAS, the contract with MV Transportation, Inc., may be extended under Section 17 of the agreement entitled "Modification", the agreement may be amended or modified unless in writing and signed by both parties; and
- **WHEREAS**, the provider has agreed to the continuation of services to the City under the same terms and conditions until advised otherwise; and

NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

- **Section 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
- **Section 2.** That the City Commission accepts the recommendation of the Chief Procurement Officer to extend the Trolley Operation Services RFP 2017.03.MS with MV Transportation, Inc., pursuant to Section 2-764 of the Procurement Code entitled "Approval of change orders and contract modifications," on a month-to-month basis, in the estimated amount of \$135,000 per month not to exceed the available budget.
- Section 3. That this Resolution shall become effective upon the date of its adoption herein.
