artwork on Miracle Mile in the public right-of-way. The proposal included images of a large scale artwork in front of the business by artist Mario Almaguer, who is currently being exhibited in the gallery. The Panel focused their discussion on whether it was appropriate to have artworks on the right-of-way that are associated with a commercial business. (Following the meeting, staff confirmed that it is a violation of the Zoning Code Section 3-403 re. Business outside a building, which prohibits merchandise for the purpose of display and/or sales outside the confines of any buildings or structures.) The Panel discussed developing standards for installation proposals of private works on public property. Without further discussion, the following motion was made.
