On Tuesday, June 13, 2023, Mrs. Maria Teresa Salsberg (Reporting party) called the Coral Gables Police Department front desk to file an incident report.

Mrs. Salsberg stated that since April 3, 2023, she has been fixing multiple code violations for her residence (Cross reference case#23002184 and code enforcement case#NOVI-23-04-1932). Mrs. Salsberg advised she went through the property insurance company (Citizens Insurance) and was on the final steps of getting the insurance claim. Still, she was informed by the insurance adjuster that the claim was not approved at the last minute due to an alleged open fraud claim opened for the property.

According to Mrs. Salsberg, she is in an ongoing legal dispute concerning the lawful guardianship of her elderly mother-in-law with her mother's in-law son Mr. Steven Joseph Salsberg (Involved Other). Mrs. Salsberg advised that, as of now, the ownership of the residence is split 50/50 between her and her mother-in-law. Still, Mr. Salsberg has sent fictitious letters to the insurance company claiming legal guardianship of his mother. As a result, the insurance company opted to stop the claim pending further investigation.

Mrs. Salsberg further stated that she had hired a lawyer regarding her mother's in-law legal guardianship, and a court hearing was scheduled towards the end of the month.

Mrs. Salsberg advised that due to the cancellation of the insurance claim, the code enforcement issues related to the house would not be able to be fixed, and she will miss the dateline given by the Coral Gables code enforcement office.

Mrs. Salsberg was provided with a case number.
