J. BRUCE EHRENHAFT PERSONAL STATEMENT – RESUME

Bruce Ehrenhaft, a resident of Coral Gables since 1991, has a BA degree with a major in Biology, an MA degree with an emphasis in Photography, and a JD degree.

Since childhood he has maintained a keen interest in the architectural, archeological and ecological resources in and surrounding the communities where he has resided or worked.

Those interests began when in the 1950's and early 1960's Bruce was raised in lowa City, the old Territorial Capital of Iowa. There was a rich history of Woodlands Native American populations who had lived in the region; and dating from the period of westward expansion by European settlers there were still existing wonderful examples of log pioneer homes and more permanent limestone and brick structures dating from the 1840's. Bruce was also fascinated by the large inventory of other 19th and 20th Century residential, commercial, and institutional buildings in various styles throughout the community. During this same mid-20th Century period - - characterized by urban growth, construction of single-family tract housing and shopping malls, and pressure for urban renewal - - Bruce was impressed by successful calls to action from throughout the community which resisted wholesale demolition of older structures inside and outside the urban core. The result was that large portions of the architectural fabric in the City's historic downtown were sensitively restored for adaptive reuse, and, simultaneously, entire neighborhoods comprised of 19th and early 20th Century residential structures throughout the City were preserved, intact. Also intrigued by architectural designs from masters like Louis Sullivan and Frank Lloyd Wright in surrounding regions, Bruce contemplated becoming an architect, but instead chose the study of biology and other sciences.

After working as a physiology research assistant in Iowa and Alaska, and on the staff of a research laboratory located in an Alaskan Inuit community, Bruce served as an assistant during a 4-month survey of archeological sites along the arctic coasts of Canada and Alaska. Later, after working as a medical photographer in a university hospital's pathology department and as a technician in its blood bank and transfusion service collecting and preparing blood components for individuals in the general patient population and for others in an NIH clinical leukemia study, Bruce did hospital based technical and educational services work throughout Spain, the Caribbean and Latin America for two American medical manufacturers. In 1985 he changed careers, studied law, and was a staff attorney for the U.S. District Court in Miami for 24 years.

Upon his retirement in July 2014 Bruce re-embraced his interests in archeology, ecology, and architecture, and their importance to the fabric of communities, by joining the Advocacy Committee of Dade Heritage Trust (DHT). In November 2015 he became a member of DHT's Board of Directors; and he is a member of the National Trust for Historic Preservation. His related activities included attendance at Municipal and County HP/HEP Board and Commission Meetings, and neighborhood meetings in Miami Dade County. They also have included attendance at various seminars, training sessions, and charrettes presented and/or hosted by the National Trust, Florida Trust, American Institute of Architects, Southeast Florida Regional Climate Change Compact, DHT, Miami Design Preservation League, the

Florida Department of State's Bureau of Historic Preservation (BHP) and Division of Historical Resources (DHR) and the National Alliance of Preservation Commissions (NACP), and a Florida DHR 2-day Regional Certified Local Government Historic Preservation Training in Miami.

Bruce has been a member of the Coral Gables Historic Preservation Board since 2017, and served as its Chair for one term (2019 – 2020).
