A motion was made by Mr. Valdes-Fauli and seconded by Mr. Fliss to approve the meeting minutes of March 18, 2025. The motion passed unanimously.

B. NEW BUSINESS

RESOLUTION NO. 2025-94**B.-1. [23-5861](#)**

A Resolution of the City Commission approving the City Manager to enter into an agreement with the Estate of Frank Stella for acquisition of artwork by the artist Frank Stella and approving integration of the artwork into the design of the Fred B. Hartnett Ponce Circle Park project (recommended by the Cultural Development Board approval/denial vote: 5 to 2); and authorizing an amendment to the Fiscal Year 2024-2025 amended budget to recognize a transfer of \$2,040,000 from the art in public places reserve as revenue, and appropriating such funds to put toward the project.

Staff presented a proposal of a monumental sculpture by artist Frank Stella, which was sent to the city through the Estate of Frank Stella following the artist's death. Background on the artist and specifications about the artwork were reviewed with staff noting that the piece will be appraised. The Estate is offering the sculpture to the city for \$2 million dollars. Staff reported that additional funds are needed to cover packing, transportation, and delivery, which the Estate has agreed to facilitate.

Mr. Valdes-Fauli made a motion to defer the item until a formal recommendation could be provided by the Arts Advisory Panel. Ms. Requena seconded the motion and discussion followed. Staff shared the remarks from the previous Arts Advisory Panel meeting, although the Panel did not have a quorum and therefore could not make a motion. The motion did not pass, with three in favor and four opposed.

Discussion continued with members expressing their appreciation of the artwork and reduced cost.

Following discussion, a motion was made to recommend the artwork for acquisition. Upon the motion passing, the Board discussed availability for a member to speak on behalf of the Board at the City Commission meeting. and the following motion was made:

Mr. Rodriguez made a motion nominating Ms. Burgos, with Mr. Fliss as a backup, to speak on behalf of the Board at the City Commission meeting addressing this item. Mr. Fliss seconded the motion which passed unanimously.

Board members re-affirmed their recommendation to have significant artwork in Ponce Circle Park and encouraged the city to include the piece

as part of the new re-design.

A motion was made by Mr. Rodriguez to recommend purchase of the Frank Stella sculpture "Puffed and Inverted Star II" as presented. Ms. Burgos seconded the motion, which passed with five in favor and two opposed.
