RESOLUTION NO. 2023-92

A RESOLUTION OF THE CITY COMMISSION DIRECTING THE CITY MANAGER TO ADOPT AND IMPLEMENT AN ADMINISTRATIVE ORDER REGARDING ENFORCEMENT OF RESTRICTIONS PERTAINING TO THE PRESENCE OF DOGS IN CITY PARKS.

WHEREAS, the City is in the process of opening its first official dog park at Salvadore Park and in the midst of public meetings and study regarding other potential dog park and dog play areas; and

WHEREAS, as the number of locations in the City available for dogs increases the City Commission wishes for the City Manager to adopt and implement a clear policy regarding enforcement of any new and existing restrictions related to the presence of dogs in City parks; and

WHEREAS, the City Commission desires that all City residents and visitors utilizing City parks have enjoyable and safe visits to City parks and finds that the City Manager’s adoption of an administrative order regarding existing and future regulations regarding parks will be helpful to ensure harmonious use of the City facilities; and

WHEREAS, the City Commission understands that this Administrative Order may be amended by the City Manager from time to time as policies, procedures, and regulations change;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:


SECTION 1. That the foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission directs the City Manager to adopt and implement an Administrative Order regarding enforcement of restrictions pertaining to the presence of dogs in City Parks and, as is within the Manager’s powers and purview, it be amended from time to time as deemed necessary by the Manager.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
