Charter says, the Commission could have split the department, could have created a new department by a vote of at least three Commissioners with an ordinance. It was never done. So, you don't need to do this. You can just put it together, back to normal and that would be a good saving measure, Mr. Manager, because you would have one director, instead of two. So instead of spending 22/23, let me give you the figures passed; 22/23, we have \$171,000 for Labor Relations, and \$196,000, I believe for Human Resources. If you combine everything under Human Resources, its \$196 instead of \$171 plus \$196. Good job.

Mayor Lago: Thank you very much. Moving on.

City Clerk Urquia: Mr. Mayor just before you move on. The change was approved by the Commission when they adopted the budget for that year by ordinance.

Mayor Lago: Again, I knew that, but at the end of the day.
