are in violation of the following sections of the City Code of the City of Coral Gables:

**Sec. 105-278. - Floors, walls, ceilings and roofs.&#x0D;**  
**Floors, walls, ceilings and roofs of every structure used for human habitation shall be**  
**structurally sound, and maintained in a clean and sanitary condition. They shall be free from**  
**cracks, breaks, loose plaster and similar conditions so serious as to endanger the safety of**  
**occupants or to seriously mar the attractiveness of the premises.&#x0D;**

**The following steps should be taken to correct the violation:**

Remedy: Must repair and clean roof. Must pull permits.

As a result of the above violation(s), a complaint has been filed against you and you are hereby  
commanded to appear before the Code Enforcement Board for a hearing on 11/20/2024 at 08:30 AM in  
the Commission Chambers, located on the second floor of:

**City Hall**

**Coral Gables, FL 33134**

This is your notice to appear at said time and place. Failure to do so will result in the matter being heard  
in absentia. An administrative fee of \$108.75 will be assessed at the time of your hearing.

Please be advised that if someone will be attending the hearing on your behalf, he or she must provide a  
power of attorney from you at the time of the hearing.

If this notice pertains to failure to maintain a historic structure, please be advised that:

- You may be subject to substantial fines that may not be mitigated
- You may also be required to repair or restore the historic structure.
- If the historic structure is allowed to deteriorate to the point where it must be demolished:
  - The City Code requires that you replace the structure with a similar historically appropriate structure; and
  - The property will no longer qualify for an historic preservation tax exemption
