Resolution re-designating the Traffic Circle at the intersection of Segovia Street and Biltmore Way from road right-of-way to City of Coral Gables property; directing the City Manager to modify all maps of the City to reflect this change in designation, apply to the Miami-Dade County Property Appraiser for a separate folio number for such parcel and to record this Resolution in the public records of Miami-Dade County.

City Attorney Leen: Mayor, I'm sorry Commissioner, may I raise I-1 very quickly because the attorney is here, it should be a very quick item.

Mayor Cason: Alright. Go ahead.

City Attorney Leen: It's just an approval. I-1, this was provided to the Commission as well. This

is regarding the circles, the circle at Segovia and Coral Way and the one at Biltmore Way. What

this does is it allows us to re-designate the circle portion for the City right-of-way, the circle

that's the City's, as City land, and the County is doing the same thing regarding their circle and

they are designating it as County land. There are sketches in the resolution that I forwarded to

you that I'm placing in the record; and what this does is it allows us to put this artwork there and

we are very appreciative of the County. Obviously, like I said, we work well with the County on

almost every matter and this is one we have and we are appreciative of it. I have special land use

counsel, if you'd like to say a couple of words.

Mr. Greg Collard: Hi, Greg Collard, special land use counsel for the City of Coral Gables,

formally the Assistant County Attorney for Miami-Dade County for about 36 years. This issue

relates to a problem in the County's Code that prohibits obstructions in map streets and these

circles that have been created are still considered right-of-way and map streets. What this item

does and what the County's item will do is get this out of the map street definition so that they

can place the art projects on these circles.

Commissioner Lago: So this is red tape and bureaucracy at its finest, at least it was resolved.

Mayor Cason: It's a great solution. So we can put that beautiful flower.

Commissioner Lago: Thank God it didn't get into something more significant in regards to legal

matters, because this could have been tied up for like two years. I just couldn't believe that we

were actually entertaining this in the beginning and this is an actual issue with the County.

Mayor Cason: Alright, so we have to vote on this.

City Attorney Leen: I need to give credit to Mr. Collard and to Deborah Herman.
