Hope that you are enjoying the weekend! Attached is a plan indicating where the footer which needs to be removed is located. The footer was actually a requirement of the approved demolition plan. It served to brace the walls which faced Aragon and where removed. Here is a listing of the work remaining to be done on the site:

- 1. Additional step out permanent monitoring wells in footer area need to be installed and tested.
- 2. Site Assessment Report (SAR) needs to be submitted to DERM.
- 3. Contingent on test results and DERM requirements, soil may need to be excavated.
- 4. The wall bracing footer needs to be removed. If necessary, nearby monitoring wells may need to be replaced if damaged.
- 5. The underground storage tank permit needs to be closed. The underground storage tank was already removed.
