RESOLUTION NO. 2012-21

RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO EXTEND THE LANDSCAPE MAINTENANCE SERVICES CONTRACT WITH SFM SERVICES, INC., PURSUANT TO SECTION 2-829 OF THE PROCUREMENT CODE ENTITLED "APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS," ON A MONTH-TO-MONTH BASIS FROM FEBRUARY 1, 2012, FOR A PERIOD NOT TO EXCEED THREE (3) MONTHS TO PROVIDE TIME TO COMPLETE THE REQUEST FOR PROPOSAL (RFP) PROCESS AND TO APPROVE AND EXECUTE A NEW CONTRACT.

WHEREAS, on November 20, 2001, the City Commission approved a contract to run from January 11, 2002, through September 30, 2006, for landscape maintenance services for various locations in the City of Coral Gables, which provided for a negotiated extension for an additional (5) years; and

WHEREAS, on October 5, 2006, this contract was extended until September 30, 2011; and

WHEREAS, on August 24, 2010, and October 12, 2010, the City Commission approved amendments to this contract, which added more locations for landscape maintenance services; and

WHEREAS, on September 13, 2011, the City Commission approved an extension of this contract to provide time to solicit proposals and to execute and new contract; and

WHEREAS, the Chief Procurement Officer recommends that the current contract again be extended on a month-to-month basis from February 1, 2012, for a period not to exceed three (3) months to provide sufficient time to complete the Request for Proposal (RFP) process and to approve and execute a new contract; and

WHEREAS, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts; and

WHEREAS, the Landscape Maintenance Services contract with SFM Services, Inc., may be extended under Section 2-829 of the Procurement Code entitled "Approval of Change Orders and Contract Modifications";

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accept the recommendation of the Chief Procurement Officer to extend the Landscape Maintenance Services Contract with SFM Services, Inc., pursuant to Section 2-829 of the Procurement Code entitled “Approval of Change Orders and Contract Modifications,” on a month-to-month basis from February 1, 2012, for a period not to exceed three (3) months to provide time to complete the Request for Proposal (RFP) process and to approve and execute a new contract.

SECTION 3. That all Resolutions or parts of Resolutions inconsistent with, or in conflict herewith, shall be and are hereby repealed insofar as there is conflict or inconsistency.

SECTION 4. That this Resolution shall become effective upon the date of its passage and adoption herein.
