RESOLUTION NO. 2010-286

RESOLUTION GRANTING APPROVAL FOR A ONE HOUR COURTESY PARKING PROGRAM FOR ON-STREET PARKING METERS WITHIN THE BUSINESS IMPROVEMENT DISTRICT FOR CALENDAR YEAR 2010, COVERING A PERIOD FROM DECEMBER 15TH THROUGH DECEMBER 26TH; FURTHER PROVIDING FOR AN EXTENSION OF SAID TIME PERIOD FROM TEN (10) CALENDAR DAYS TO TWENTY (20) DAYS FOR EACH YEAR THEREAFTER.

WHEREAS, The City of Coral Gables has historically provided within the Business Improvement District a courtesy notice to vehicles parked at expired meters during a portion of the Holiday shopping season; and

WHEREAS, this notice provides for an additional hour of parking before a citation is issued for parking at an expired meter; and

WHEREAS, the City desires to continue this program;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. The City Commission does hereby authorize the City Manager to allow during the period between December 15th and December 26th for this year, and for a (twenty) 20-day period for each year thereafter that parking enforcement officers provide a one hour courtesy for any vehicle parked at an expired meter within the Business Improvement District.

SECTION 3. That no citation for an expired meter violation shall be issued unless the meter remains expired beyond one hour after the initial expiration of the meter.

SECTION 4. That this resolution shall become effective upon the date of its passage and adoption herein.

*[Note: Please note that because Christmas Day, the 25th is included within the calculation of the 10-day courtesy parking program timeline and there will be no enforcement on said day, said period cove red will extend to December 26, 2010].


