The undersigned are the affected Property Owners by the Proposed Amendment to the Declaration of Restrictions to the property described in the Subject heading herein.

Elected Officials, the purpose of this letter, is to seek your vote in support in addressing the issue of amending the Declaration of Restrictions and to express what is acceptable to us as the affected neighbors.

In order to preserve the image of our "City Beautiful" standards, we are requesting the following:

1. A hedge of at least 8 feet tall surrounding the three (3) sides of the property, (West, San Miguel and the East side)
2. An irrigation system with a fertilizer component for adequate maintenance and growth of the hedge
3. Restricting the entrance to the parking lot to not earlier than 7:00 am thus complying with the Nuisance Ordinance and easing the neighbors of the annoyance
4. A metal gate an access timer to secure and enforce the usage of the parking lot area.
