Presentation of a Proclamation declaring September 17-23, 2025 as "Constitution Week" in Coral Gables.

Mayor Lago introduced the proclamation declaring September 17-23, 2025, as "Constitution Week" in Coral Gables. He stated that this is a personal favorite of his every year, and he looks forward to "Constitutional Week" and spending time with former Mayor Thomson, but also because the constitution is the backbone of what makes this country what it is. He then read the proclamation. Former Mayor Thomson accepted the proclamation and reminded everyone that this is an annual event in which she comes to the City Commission meeting every year in September and has done so for 45 years. She then introduced Penelope Johnson Vice Regent of Daughters of the Revolution (DAR) Coral Gables Chapter, which was organized October 20, 1928, whose motto is "Love in Our Hearts and United Hands". The Chapter met at Coral Gables Merrick House but no longer meet there because it became too prohibitive in rent and insurance for Chapter meetings. There are about 35 to 40 members and they meet once a year and all dues from members are given to DAR children's charities around the country. She wondered if something could be done to assist them with a venue because they have been meeting outside of the city. Ms. Johnson thanked the Mayor and City Commission and residents for the proclamation, and it is an honor to continue the long-standing mission of historic preservation, patriotism and education of. This week commemorates not only the signing of the US. Constitution but reminds us of the importance of protecting the freedoms and rights that it guarantees. She is grateful for the city's partnership in helping them raise awareness and inspire future generations to cherish and uphold this foundational document. Mayor Lago instructed the City Manager to look for a conference room somewhere in the city to accommodate DAR for their meetings along with free parking. Former Mayor Thomson spoke about the park opening in her honor and the gifts that she will be giving to the children attending. She also spoke of the significance of the park's location because it was previously owned by the Granada Presbyterian Church, where she has attended for 70 years and where she got married to husband Jack in 1953, where her four children were baptized and two or three of them were married. She is overwhelmed with gratitude to Mayor Lago, the City Commission and the city for the honor of having a park named after her, something that usually occurs when the individual is deceased. Commissioner Fernandez welcomed Ms. Johnson in her new role and thanked them for all they do at the DAR. He also shared information regarding the ribbon cutting ceremony at the park to commemorate its grand opening and whose theme is from the Wizard of Oz.

Accepting the proclamation was Sylvia Vanni and Christina Duenas from Mystic Force Foundation for Childhood Cancer. Both ladies thanked the Mayor and City Commission for the proclamation, and a flyer was distributed to the officials on the dais which showed the many children who have suffered and/or passed away from cancer. They both spoke of their personal experiences having a child who had died from this dreaded disease and the other living with the disease and undergoing numerous operations and living in constant pain. Additionally, it was pointed out that progress has been made in sending individuals to the moon and yet there is no cure for this disease. Their purpose was to bring awareness of this disease and how it affects the individuals as well as their family left behind and that children deserve better. Mayor Lago thanked them for coming and Vice Mayor Anderson stated that it was a moving presentation and having participated in the groundbreaking event for the Ronald McDonald House, Give Hope a Home which is a great opportunity for families struggling with treatment for their children and being afforded accommodations next to the treatment center. She also spoke of other opportunities to support in funding this great cause.
