A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE APPOINTMENT OF COMMISSIONER CASTRO TO SERVE AS A MEMBER OF ONE OF THE 2025–2026 FLORIDA LEAGUE OF CITIES LEGISLATIVE POLICY COMMITTEES AND AUTHORIZING COMMISSIONER CASTRO TO ADVOCATE FOR THE CITY'S LEGISLATIVE PRIORITIES.

- **WHEREAS**, the Florida League of Cities (League) is an organization that advocates on behalf of Florida's cities at the state and federal levels and promotes self-governance to help ensure local governments make local choices for their populous; and
- **WHEREAS**, the League annually convenes legislative policy committees (Committees) where representatives from Florida's cities brainstorm ideas and help develop the League's legislative platform; and
- **WHEREAS**, the League appointed Commissioner Castro to serve as Vice Chair of the Development, Code Compliance, Redevelopment Committee;

NOW, THEREFORE, BE IT DULY RESOLVED BY THE CITY COMMISSION OF CORAL GABLES, FLORIDA:

- **SECTION 1**. That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
- **SECTION 2**. That the City Commission hereby accepts the appointment of Commissioner Castro to represent the interests of Coral Gables and serve on the Development, Code Compliance, and Redevelopment Committee for the 2025–2026 term as Vice Chair.
- **SECTION 3.** That the Commissioner shall put forth and advocate for only those legislative priorities adopted by the City Commission.
- **SECTION 4.** That Commissioner Castro is designated to represent the City Commission in all the meetings and events directly associated with her position on the 2025-2026 Florida League of Cities Policy Committees
- **SECTION 5**. This Resolution shall become effective upon the date of its passage and adoption herein.
