RESOLUTION NO. 2021-283

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING AN EXTENSION THROUGH OCTOBER 26, 2021 OF A ZONING IN PROGRESS RELATED TO THE INCENTIVES AND/OR BONUSES PROVIDED IN SECTION 5-200 OF THE ZONING CODE “MEDITERRANEAN STANDARDS,” FOR NEW COMMERCIAL, MIXED-USE, AND MULTI-FAMILY PROJECTS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on July 13, 2021, the Commission adopted Resolution No. 2021-194 (the “Zoning in Progress Resolution”) issuing a forty-two-day (42-day) Zoning in Progress in accordance with Section 14-209 of the Zoning Code for consideration of Zoning Code Text Amendments to Section 5-200 “Mediterranean Standards” for new commercial, mixed-use, and multi-family projects; and

WHEREAS, Section 4 of the Zoning in Progress Resolution provides that it may be reasonably extended, if necessary, by Resolution of the City Commission and the City Commission has extended the Zoning in Progress once, pursuant to Resolution No. 2021-228, through September 28, 2021; and

WHEREAS, the Blue Ribbon Committee has made certain recommendations regarding possible amendments to Section 5-200 of the Zoning Code, and it is contemplated that such proposed Zoning Code text amendments will be considered on first reading by the City Commission on October 12, 2021; and

WHEREAS, additional time is needed for review of the proposed Zoning Code text amendments by the Blue Ribbon Committee, the Planning and Zoning Board, and for consideration by the City Commission on first reading and second reading; and

WHEREAS, the City Commission finds that the public interest requires an extension of the Zoning in Progress Resolution through October 26, 2021 and that such extension is reasonably necessary to allow the Blue Ribbon Committee to finish its work and to allow the Planning and Zoning Board and this Commission to review and vote on the proposed Zoning Code text amendments to Section 5-200;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES THAT:

SECTION 1. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


SECTION 2. The City Commission authorizes an extension of the Zoning in Progress Resolution through October 26, 2021.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
