Mayor Lago introduced Agenda Item A-2 Congratulations to Driver Engineer Brandon Ogden recipient of the "Firefighter of the Month Award" for the month of June 2023 and Fire Chief de la Rosa made the presentation. Fire Chief de la Rosa said that one of the challenges given to firefighters is that they own it, that is of their success, career, crew, and that of their community. Driver Engineer Ogden took that challenge and ownership. He is part of a family tradition in that his father was a captain with the city. Firefighter Ogden was also nominated because he took the initiative to develop a training modality on how they pack and deploy their fire hoses. Mayor Lago introduced Agenda Item A-3 Innovation and Technology Department Presentation: Three prestigious international Smart City Awards received over the past six months, as of May 2023 and Information and Technology Director, Raimundo Rodolfo accompanied by members of his staff made the presentation in which the city was awarded three Smart Cities Awards, namely, 2023 Smart 50 Award, 2023 Smart21 Communities of the Year and 2022 IEEE Smart Cities Jury Award. A slide was shown, and Mr. Rodolfo gave the background pertaining to each award and the

applicability within each aspect of the city as well as entities they partnered with.
