RESOLUTION NO. 2010-56

RESOLUTION RESCINDING RESOLUTION 2009-81, THAT AUTHORIZED THE PURCHASE OF A MACK 2 LOW PROFILE SURFACE DREDGER FROM LIVERPOOL WATER WITCH MARINE & ENGINEERING COMPANY, LTD., FROM LIVERPOOL, UK AND AMENDING RESOLUTION 2009-137 BY NOT APPROPRIATING THE FUNDS FROM THE STORMWATER UTILITY FUND FOR SAID PURCHASE.

WHEREAS, the Public Works Department currently utilizes a Water Witch to perform maintenance on City canals such as seaweed removal and bridge repair, with the vessel being in operation approximately one-hundred twenty (120) hours per year; and

WHEREAS, on March 24, 2008, the City Commission passed and adopted Resolution 2009-81 which authorized the purchase of a new Mack 2 Low Profile Surface Dredger from Liverpool Water Witch Marine & Engineering Co. Ltd., of Liverpool, UK at a cost of £129,600.00 (\$178,273.26 USD); and

WHEREAS, the current cost of the vessel is £137,305.00 (\$208,549.74 USD); and

WHEREAS, the Automotive Department is refurbishing the existing Water Witch Vessel at a cost of approximately \$10,000.00 to an operating condition that meets the City's canal maintenance requirements for the foreseeable future thereby eliminating the need to purchase the new Mack 2 Vessel; and

WHEREAS, in accordance with Section 2-829 of the Procurement Code, the City Commission upon the recommendation of the City Manager has the sole authority to rescind an award on a single purchase in excess of \$100,000.00;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are ratified and confirmed as being true and correct and are hereby made a specific part of this resolution upon adoption hereof.

SECTION 2. That the City Commission does hereby rescind Resolution 2009-81, that authorized the purchase of a Mack 2 Low Profile Surface Dredger from Liverpool Water Witch Marine & Engineering Co. Ltd., in accordance with Section 2-829 of the Procurement Code; and does hereby amend Resolution 2009-137, by not appropriating the funds from the Stormwater Utility Fund for said purchase.

SECTION 3. That this resolution shall become effective upon the date of its passage and adoption herein.


