RESOLUTION NO. 2019-126 (AS AMENDED)

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING SATCHMO BLUES BAR AND GRILL, INC. TO SELL ALCOHOLIC BEVERAGES AND TO AUTHORIZE WAIVER OF SPECIAL EVENT CODE SECTION 62-260 OF THE CITY CODE ALLOWING THE ABOVE-MENTIONED APPLICANT TO OPERATE BEGINNING AT 12:00 NOON UNTIL 11:00 P.M., AT THE PLAZA LOCATED AT 60 MERRICK WAY FROM TUESDAY, JULY 2, 2019 THROUGH SUNDAY, JULY 7, 2019, WITH THE EXCEPTION OF JULY 4, 2019, DURING THE ***“2019 FIFA WOMEN’S WORLD CUP CELEBRATION AND 2019 COPA AMERICA WATCH PARTY.”*** PART OF THE PROCEEDS TO BENEFIT THE CORAL GABLES CULTURAL AFFAIRS COUNCIL; SUBJECT TO FLORIDA DEPARTMENT OF PROFESSIONAL REGULATION REQUIREMENTS.

WHEREAS, Satchmo Blues Bar and Grill, Inc.’s requests approval to serve alcoholic beverages during the celebration of the ***“2019 FIFA Women’s World Cup Celebration”*** in Coral Gables and ***“COPA America Watch Party”*** is approved; subject to Florida Department of Professional Regulation Requirements; and

WHEREAS, the ***“2019 FIFA Women’s World Cup Celebration and 2019 COPA America Watch Party”*** will take place beginning at 12:00 noon until 11:00 p.m., Tuesday, July 2, 2019, through Wednesday, July 3, 2019, ceasing activities on Thursday, July 4, 2019 and resuming Friday, July 5, 2019 through Sunday, July 7, 2019. All viewing events are scheduled to end by 9:00 p.m. Partial proceeds will be donated to the Coral Gables Cultural Affairs Council; and

WHEREAS, this request is for an event that is greater than four consecutive days and also takes place on several days of the week which requires a waiver of City Code section 62-260(b) of the City Code: “No single special event or parade shall be conducted for more than four consecutive days. No single special event or parade shall be conducted on any consecutive days of the week other than Thursday, Friday, Saturday or Sunday”;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing **“WHEREAS”** clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission hereby waives Section 62-260 of the City Code and authorizes Satchmo Blues Bar and Grill, Inc., to operate from 12 p.m. to 11 p.m. at the Plaza located at 60 Merrick Way from Tuesday, July 2, 2019 through Wednesday, July 3, 2019, ceasing activities on Thursday, July 4, 2019 and resuming Friday, July 5, 2019 through

Sunday, July 7, 2019 during the “2019 FIFA Women’s World Cup Celebration and 2019 COPA America Watch Party.”

SECTION 3. That Satchmo Blues Bar and Grill, Inc, is authorized to leave the tents and screens assembled on the Plaza located at 60 Merrick Way on July 4, 2019 but no events will be held on this date. The Commission waives the permit fee for July 4, 2019.

SECTION 4. That this Resolution shall become effective upon the date of its passage and adoption herein.
