## **RESOLUTION NO. 2022-31**

A RESOLUTION OF THE CITY COMMISSION APPROVING ENTERING INTO AN AGREEMENT WITH ART CONSERVATORS LAB TO COMPLETE PUBLIC ART RESTORATION OF APPROXIMATELY 15 ARTWORKS; AND AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2021-2022 AMENDED BUDGET TO RECOGNIZE AS REVENUE A TRANSFER FROM THE ART IN PUBLIC PLACES RESERVE, AND APPROPRIATING SUCH FUNDS TO PUT TOWARD THE COST OF THE RESTORATION PROJECT.

- **WHEREAS,** Public artworks in the City's collection require restoration based on the recent professional condition assessment completed by Evergreene Architectural Arts; and
- **WHEREAS**, artworks in the collection require an ongoing maintenance plan and schedule; and
- **WHEREAS**, a Request for Proposals was posted on October 8, 2021 for restoration treatment, stabilization, and ongoing recommended maintenance of approximately 15 artworks; and
- **WHEREAS,** professional conservation and restoration professionals were approached and asked to submit bids for the assessment; and
- **WHEREAS**, staff recommends contracting with Art Conservators Lab for the project at an estimated fee of \$167,000 plus an estimated \$10,000 for related expenses; and
- **WHEREAS**, funds for a portion of the project have been approved and an amendment to the Adopted Fiscal Year 2020-2021 Budget is required to transfer the balance from the Art in Public Places reserve and appropriate such funds toward the project;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

- **SECTION 1.** That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.
- **SECTION 2.** The City Commission does hereby authorize entering into an agreement with Art Conservators Lab for the public art restoration project.

**SECTION 3.** That the Commission does hereby authorize an amendment to the Adopted Fiscal Year 2021-2022 Budget to transfer \$17,850 from Art in Public Places fund balance; and appropriate such funds to put toward the project.

**SECTION 4.** That this Resolution shall become effective upon the date of its passage and adoption herein.
