Mayor Lago introduced Agenda Item A-2, a presentation of a proclamation declaring July 25, 2022, as "Steve and Heidi Wright Day" in Coral Gables. Commissioner Menendez stated that it was an honor to recognize Steve Wright an award-winning journalist and Heidi Wright a life-long public servant and Americans with Disabilities expert, and that this couple has done amazing work in the community teaming-up to create a groundbreaking university design course at the University of Miami Architectural School, and then expounded on the relevance of this course. Commissioner Anderson before reading the proclamation spoke of having the opportunity to represent individuals with disabilities in her law practice and having individuals in her family who are disabled, and in doing so, it was an educational experience learning of all the barriers that exists to enjoy life as an abled-bodied individual; that many may encounter disabilities as they age and having accessibility in historic buildings is possible. She then read the proclamation. Mr. Wright eloquently stated that if your city is not inclusive to everyone, it serves no one. Ms. Wright thanked the City Commission for the deeply appreciated honor for the work that they do, which they feel is nothing out of the ordinary, but something they do all the time, always looking at things from a different perspective with the objective of making spaces whether it is inside or outside welcoming to everyone. Mayor Lago on behalf of the City Commission thanked them for all they do.

Mayor Lago introduced Agenda Item A-3 pertaining to a Certification of Recognition to Dr. Tina Carroll-Scott, M.D., and Commissioner Menendez made the presentation regarding Dr. Carroll-Scott, a Board-Certified Pediatrician practicing for over 25 years. She attended many prestigious schools and did her internship and residency in numerous renowned hospitals, building her career focusing on populations in need by caring for immigrant families, farm workers in Ft. Pierce, Florida and now with families and children who are uninsured or underinsured with the goal of providing free healthcare and debunking the idea that free healthcare means substandard healthcare. She believes that improved access to healthcare would give these children the foundation to build healthier minds and bodies. In her clinic she provides numerous services for example medical, psycho-social, as well as the economic problems facing these families. During COVID-19, she was instrumental in educating the community regarding the vaccines throughout the pandemic, holding 4 pop-up vaccine events at her clinic to improve access and equity in communities of color. Currently she is organizing a 5k event called “The 5K Gallop Trot” at Zoo Miami “on August 27, 2022 to raise funds for schools in Jamaica hard hit during the pandemic, loss of in-person learning and vital resources, and many of these schools have educated many Jamaicans residing in South Florida for decades and who continue to have a significant impact on all communities and across all professions. Miami-Dade County Mayor Daniella Levine-Cava will be presenting a proclamation to her at the event in honor of Jamaica’s 60th Independence anniversary on August 6, 2022. He considers Dr. Scott “a force to be reckoned with” and is deeply grateful for her dedication, tireless and selfless service in serving and protecting children and families in need and he is in awe of the work that she is doing. Dr. Carroll-Scott thanked Commissioner Menendez for his introduction and stated that she is a resident of Coral Gables since 2000, is of Jamaican descent, and the event is personal to her because of her strong upbringing based on education and giving back, which is why she frequently visits Jamaica continually reaching out to the less fortunate. This is her first time doing the event, she has a website and has raised \$35,000.00, and asked for the city to support the event and diversity. Mayor Lago in thanking her for her endeavors said the city is blessed to have a prominent doctor as herself in the community, and it will be a privilege to support her efforts and she should send the information to the City Commission regarding the event.

Mayor Lago introduced Agenda Item A-4, congratulations to the City of Coral Gables for Achieving LEED Gold Certification for Cities and Communities. Mr. Matt Anderson, Resiliency and Sustainability Manager/Public Works Department stated that it was a great achievement for the city to receive LEED Gold Certification, thanked the City Manager and gave an overview of the city's accomplishments, including a \$25,000.00 scholarship with access to the ARC database, memberships, technical assistance, etcetera, as well as addressed buildings requirements when qualifying for LEED certification, and in so doing demonstrates the city's commitment to sustainability, human health, and economic prosperity. He then introduced Hilari Varnadore (Vice President for Cities) and David Abell (Senior Manager for LEED for Cities), both from the USGBC LEED for Cities and Communities Program who attended via Zoom. Both thanked the Mayor and City Commission for inviting them to celebrate the City's LEED Gold certification and commended the city on its achievement, commitment, and accountability in having a better community for all residents. Mayor Lago recapped on the city's Sustainability Master Plan that within the next 6-12 months they are going to show the Metrix as to what the city is doing to reduce its carbon emission where sustainably possible. The city also has one of the largest charging grids possibly in South Florida and other cities have come to see how the city is doing it. Originally, he continued, it was only for Tessler vehicles, and the city is now working to ensure that the charging stations would be used for all vehicles, and the superchargers would be a game changer in the City of Coral Gables. He then thanked Mr. Anderson for his leadership, Public Works Department and his team who were involved in pushing sustainability throughout the City.
