## **RESOLUTION NO. 2022-182**

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD THE LANDSCAPING SERVICES (PONCE DE LEON BLVD.) THE NATIVE GUY, LLC, THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, IN THE ANNUAL ESTIMATED AMOUNT OF \$175,939, PURSUANT TO INVITATION TO BIDS (IFB) 2022-013 **SECTION** AND 2-763 THE CITY'S OF PROCUREMENT CODE ENTITLED "CONTRACT AWARD".

**WHEREAS,** on May 5, 2022, the Procurement Division of Finance formally advertised, issued and distributed the IFB for Landscaping Services (Ponce de Leon Blvd); and

**WHEREAS**, thirty-three (33) prospective bidders downloaded the IFB package from Public Purchase, the City's web-based e-Procurement service; and

**WHEREAS**, on June 9, 2022, four (4) bids were received in response to the IFB 2022-013 from Coco Tree Service Corp, SFM Landscape Services, LLC., Superior Landscaping & Lawn Services, Inc., and The Native Guy, LLC; and

WHEREAS, the Public Works Department concurs with the Chief Procurement Officer's recommendation to award the Landscaping Services (Ponce de Leon) to The Native Guy, LLC; and

**WHEREAS,** Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission accepts the recommendation of the Chief Procurement Officer authorizing the City Manager to award the Landscaping Services to The Native, LLC, the lowest responsive and responsible bidder in the estimated amount of \$175,939 but not to exceed the available and approved budget, pursuant to Invitation

for Bids (IFB) 2022-013 and section 2-763 of the procurement code entitled "contract award"; further authorizing the purchase of additional units based on the available budget.

SECTION 3. That this Resolution shall become effective upon the date of its adoption herein.
