AGREEMENT FOR FY 2014-2015

ARTICLE I

The City of Coral Gables will award the Cultural Series, Festivals, & Special Events / Community Grant described herein in consideration for the Grantee's agreement to abide by the terms and conditions contained herein (this "Agreement").

1. Type of Grant: **Cultural Series, Festivals & Special Events**
2. Grant Amount: **\$2,500**
3. Grantee: **Cuban Classical Ballet of Miami, Inc.**
4. Date(s): **May 12, 2015, May 14, 2015**
5. Bank in which funds will be kept:

ARTICLE II

Conditions:

1. The Grant may be used only for the purposes expressed in the Grantee's application; according to the "Allowable Grant Expenditures" section of the Grant guidelines; and may not be used toward master classes.
2. Any change in the programming, venue(s), or dates proposed as a part of this grant shall require prior approval by the Cultural Development Board. Said approval shall be in writing, a copy of which shall be included in the Final Report.
3. The City of Coral Gables assumes no obligation to provide financial support of any type in excess of the Grant total; cost overruns are the sole responsibility of the Grantee.
4. The City of Coral Gables, through its Cultural Development Board, may monitor and will evaluate the operation of the project under this Grant.
5. Grant funds received pursuant to this Agreement shall be kept in an established financial institution, the identity and account number of which is disclosed above as part of this Agreement.
6. The Grantee must submit a Final Report on forms provided by the City by the FY2015-2016 grant application deadline. If Grantee applies for a Coral Gables cultural grant for the following Fiscal Year and the current year's project is not yet completed, a Preliminary Final Report must be submitted by the deadline of the immediately following year's grant application. A complete Final Report must still be filed within sixty (60) days of completion of the project. **Failure to submit a Final Report by the above deadline(s) will result in disqualification of the organization's grant application for the next two grant cycles.**
7. The Grantee must insert in all promotional materials and marketing materials related to this grant including public announcements, press releases, print and broadcast media, etc., the credit line: **With the support of the City of Coral Gables and/or the Coral Gables, The City Beautiful** graphic (see below) provided by the City of Coral Gables.



The Grantee recognizes that the use of the City Seal may not serve as a substitute for this requirement.

8. The Grantee is not permitted to assign this Grant; any purported assignment will be a default of this Agreement, and Grantee will be required to return the funds awarded by the City of Coral Gables.
9. The Grantee agrees to abide by all applicable Federal, State, County, and City laws and regulations, including, but not limited to, all federal statutes, executive orders, and implementing regulations related to financial transactions with prohibited countries and/or citizens of prohibited countries or prohibited persons to include those regulations set forth in Title 31 Code of Federal Regulations Section 515 et seq., as well as non-discrimination in employment on the basis of race, color, religion or national origin.
10. The City may require re-payment by certified check of all or a portion of the grant amount if Grantee is in material breach of any terms or conditions of this Agreement, including issues discovered after the presentation of the Final Report.
11. If for any reason the Grantee shall fail to fulfill in a timely and proper manner its obligations under this Agreement, the City of Coral Gables shall have the right to terminate this Agreement and require repayment of the grant amount.

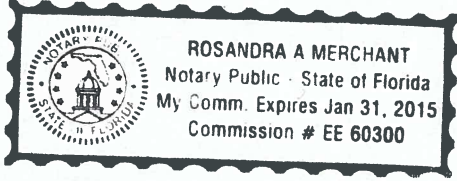
