Mayor Lago introduced Agenda Item A-1 and Vice Mayor Anderson read the Proclamation declaring April 19, 2024, as "Education and Sharing Day" in Coral Gables. Rabbi Stolik from Temple Judea stated that there are two Chabad chapters in Coral Gables and introduced Rabbi Mendy Fellig from the University of Miami Chabad. Mayor Lago introduced Agenda Item A-2: Presentation of a Proclamation declaring April 2024 as "Autism Awareness Month" in Coral Gables and acknowledged Crystal Academy and Project Victory.

Mayor Lago read the proclamation regarding Agenda Item A-2: Presentation of a Proclamation declaring April 2024 as "Autism Awareness Month" in Coral Gables and acknowledged Crystal Academy and Project Victory. Raquel Elejabarrieta, Esq., Director of Human Resources & Risk Management and Chief DEI&A Officer and Police Chief Hudak made the presentation. Director Elejabarrieta stated that the Disability Affairs Board chose the Police Department to receive the acknowledgement because of their involvement in the autism community and through a collaborative effort with disability independence groups over ten years ago they developed the Wallet Card Project. This nationally recognized program assists individuals with informing police officers of their special needs and trains them about individuals with autism. They have also been instrumental in programs where residents

provide the Police Department with information regarding individuals with autism living within the residents as well as having a police vehicle and badges are wrapped with the autism logo. Maria Palacio-Pike (Mary) of Crystal Academy stated that she is also there as the Chair of the Disability Board, thanked everyone including the Police Department for being so accepting and supportive of their community and it all started in Coral Gables which is a model for many cities. Police Chief Hudak stated that they are proud and honored to be recognized and realized that the autistic community is vital and important to them and acknowledge retired Major Bart Barta who made it his life work by changing insurance policies and continues to teach. They are not only proud to be working in Coral Gables, but to also represent all the residents. Mayor Lago also mentioned Craig E. Leen, former City Attorney, and Commissioner Raquel Regalado also advocates of the autism community.

In keeping with Autism Awareness, Mayor Lago introduced Agenda Item H.-2: A Resolution of the City Commission authorizing the City Manager to enter into a cooperative agreement with the School Board of Miami-Dade County, Florida, for Project Victory, a program that assists young adults with disabilities by providing work skills and employment training within the City of Coral Gables. Director Elejabarrieta stated that this is a special program that the city entered into two years ago with students who attend Coral Gables High School who are neurodiverse and work in City Hall and Development Services gaining employment and social skills assisting in scanning, answering the phones, calling individuals about permitting and it is a great program that currently has twelve students many of whom were present. She shared a success story in which one of the students has been gainfully employed part-time as a Human Resources Clerical Assistant greeting and answering the telephone, his name is Brandon Talavera who was a Project Victory student last year. Mr. Talavera gave a wonderful speech thanking the Mayor and City Commissioners for the opportunity given to him by the city, having worked in the Development and now in the Human Resources and Risk Department. He urged the City Commission to continue supporting the program so that many more participants can someday get job opportunities and they too can help their families. Natalie Tappert accompanied by Ms. Munoz representing transition programs from Miami-Dade Public Schools stated that the program is only successful because of the buy in and collaboration of the worksites and extended her gratitude to everyone who works in the city and for making it an awesome and productive environment. Special thanks was given to Mr. Chang who is the backbone for making sure that the students have all the opportunities to reach their highest potential and as a Coral Gables resident she is proud to be part of the City Beautiful and the things that make it the best city to live in. Mr. Chang thanked the Mayor and City Commission for their support and approval and feel that the student interns have been welcomed with opened arms, are supported and everyone is rooting for them to do well and Brandon is proof positive that they not only talk the talk but walk the walk and being the first ones to hire one of their interns and they are grateful for it. He has seen the change in Brandon, his

self-confidence, independence, it has been wonderful. He wants all his students to be hired and wants to see them all out in the community, thanked them and said they are the best and he appreciates it. The Mayor and City Commissioners all took turns in thanking Director Elejabarrieta, School Board Member Mari Teri Rojas, and Brandon. He feels blessed to have them in the city, they are a ray of sunshine. Police Chief Hudak made the presentation regarding Agenda Item A-5: Congratulations to Operator Denie Pomilban, recipient of the City of Coral Gables "Operator of the Year Award," for 2023. Police Chief Hudak spoke of what it entails to be a telecommunications operator and continued by explaining what Telecommunications Operator Pomilban did on December 22, 2023, when she was assigned to work the midnight shift in the police dispatched area. At 11:39 pm there was domestic violence in progress on Blue Road in which the subject fled the scene. A BOLO was put to the officers in the area resulting in the individual being arrested. Then there was a hit and run with injuries, she coordinated the officers and fire rescue. Following that was the suspicious individual on the 1200 block of Tangier Street. The officer gave the description of the individual who had fled on foot, and she was able to setup a perimeter with the officers in the area and then more calls came in with burglaries in the same area, and she pulled officers from the holiday task force while that was going on. It was a busy night, a total of three vehicle burglaries, two open door calls simultaneously. Then there was a burglary at 2:00 am at the 4400 block of Ponce de Leon Boulevard at the Shops at Merrick Park resulting in two subjects being arrested. In the 1000 block of West Dixie are unknown problem involving a man down and she was able to dispatch officers as well as fire rescue personnel. This is one night that can occur every night in the City of Coral Gables. It is because of her relatively new tenure to the department and her exceptional skills demonstrated on that night, she was selected and nominated, but selected by her peers that night for the Operator of the Quarter 2023 and congratulated her as did Mayor Lago. Telecommunications Operator Pomilban thanked the Mayor and City Commission, Police Chief Hudak and her colleagues and said that it was an honor to receive the award which is not only a testament to what she does, but a reflection of the collective dedication and hard work of her entire team. She expressed her gratitude to her supervisors and colleagues for their continued support and guidance and considers it a privilege to work alongside such a skilled group of professionals.
