City Attorney Suarez: F-9 is a Resolution of the City Commission ratifying and accepting resolutions passed by Miami-Dade County approving execution of interlocal agreement and calling for a special election necessary for the transfer of control from Miami-Dade County to the City of Coral Gables of Gables by the Sea-Coral Gables Security Guard Special Taxing District located entirely within the City, and authorizing the City Manager to do all things necessary to effectuate the intent of this resolution. Assistant City Attorney Gus Ceballos will present the item.

City Commission Meeting

Assistant City Attorney Ceballos: Good afternoon again. So, this item is basically just wrapping up the initial transfer of those two new districts, maybe the new Commissioners may not recall. The county does not allow any special taxing district to exist outside of their control, if it does not fall wholly within one municipality. So, Gables by the Sea is part Pinecrest, part Coral Gables. So, the only way to get around that was to dissolve the existing district and create two new districts; one that's controlled by City of Coral Gables, and one that's run by City of Pinecrest. We are in the process and that's not this item in working on an interlocal, specifically with the Village of Pinecrest, where its going to be a pass through and we are going to be the governing board for that district in its entirety, but this is basically just wrapping up the initial transfer and it was a requirement from the county and that's basically all.
