RESOLUTION NO. 2017-148

A RESOLUTION AUTHORIZING ENTERING INTO AN AMENDMENT TO AN INTERLOCAL AGREEMENT WITH MIAMI-DADE COUNTY WITH REGARD TO THE CITY OWNED CORAL GABLES LIBRARY LOCATED AT 3443 SEGOVIA ST, CORAL GABLES, FLORIDA FOR PURPOSE OF RESTORING THE FOUNTAINS AND PLAZA.

WHEREAS, per Ordinance No. 2008-104, the City and Miami-Dade County (the "County") entered into an Interlocal Agreement dated December 8th, 2008, with regard to the Coral Gables Library located at 3443 Segovia St, Coral Gables, FL (the "Agreement") to provide library services out of the City owned facility; and

WHEREAS, the Agreement clearly identifies the responsibilities of each party to the terms of the Agreement, which includes the County's responsibility for all exterior repairs and maintenance, including the maintenance and repairs of the historic fountains and plaza; and

WHEREAS, as part of the County's responsibility, the County has agreed to reimburse the City for work performed to restore the Library fountains and plaza at a cost of approximately \$190,000 using the City's contractor specializing in historic preservation; and

WHEREAS, per Resolution No. 2017-84, the City Commission authorized the Art Historic Fund to contribute Twenty-Seven Thousand Seven Hundred Fifty and 00/100 Dollars (\$27,750) of the approximate \$190,000 towards the restoration of the Library's fountains and plaza; and

WHEREAS, at their April 12, 2017 meeting, the Library Advisory Board was supportive of the County's request to have the City contract with a contractor specializing in historical preservation with the County reimbursing the City for the work and the entire Board concurred;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

SECTION 2. That the Amendment to the Agreement is hereby approved in substantially the form attached hereto as Exhibit “A.”

SECTION 3. That the City Commission does hereby authorize the City Manager to execute the Amendment with such modifications to the form attached hereto as Exhibit “A” as may be approved by the City Manager and City Attorney that are necessary to implement the intent of this resolution.

SECTION 4. That this resolution shall become effective immediately upon the date of its passage and adoption herein.




