RECOMMENDATION OF THE CITY MANAGER:


It is recommended that John Martin's Restaurant be permitted to sell alcoholic beverages from 7:00 p.m. until 12:00 midnight on Friday, October 31, 2008, on Salzedo Street from Aragon Avenue to Miracle Mile, and one half block of Aragon Avenue, as part of the Halloween Party to benefit the Young Rotarian Charity, subject to Florida Department of Professional Regulation requirements.

BRIEF HISTORY:

This request is for John Martin's to serve alcoholic beverages during the Halloween Party and is in compliance with the laws of the State of Florida.

This activity has been presented to the City's Special Events Committee with recommendation for approval. As discussed at the special events committee meeting, Salzedo Street will be closed prior to event with Police providing street closure. A stage will be set up on Salzedo Street for musical entertainment. Provisions for street clean-up and event equipment were also discussed at the meeting. In addition, a code enforcement officer will be on hand to supervise the noise level of the event. The officer will keep communication with central dispatch, will be aware of any noise complaints made and will take any steps needed to manage the noise level.

RECOMMENDATION OF THE CITY MANAGER:



BRIEF HISTORY:

This is a request for Kiwanis of Little Havana to serve alcoholic beverages during the Art in the Park event series and is in compliance with the laws of the State of Florida.

For three years, the Kiwanis of Little Havana have utilized Ponce Circle Park as the location of their Art in the Park event. Each evening will consist of art and music to coincide with Gallery Night. This activity has been presented to the City's Special Events Committee with recommendation for approval. Provisions and operations of staging, traffic and safety control, post-event clean-up and noise management were discussed at the meeting. In addition, a code enforcement officer will be on hand to supervise the noise level of the event. The officer will keep communication with central dispatch, will be aware of any noise complaints made and will take any steps needed to manage the noise level. During the final concert in last year's series, noise reduction was worked on with the noise level being reduced throughout the night, and the results were positive. This technique will continue this year.
