RESOLUTION NO. HPR329-LHD2022-007

A RESOLUTION DESIGNATING THEREON AS A LOCAL HISTORIC LANDMARK THE PROPERTY LOCATED AT 1221 MILAN AVENUE, CORAL GABLES, FLORIDA, LEGALLY DESCRIBED AS LOT 9, BLOCK 39, CORAL GABLES GRANADA SECTION, ACCORDING TO THE PLAT THEREOF, AS RECORDED IN PLAT BOOK 8, AT PAGE 113 OF THE PUBLIC RECORDS OF MIAMI-DADE COUNTY, FLORIDA; AND REPEALING ALL RESOLUTIONS INCONSISTENT HEREWITH.

WHEREAS, a public hearing of the Coral Gables Historic Preservation Board was advertised and held, as required by law, and all interested parties concerned in the matter were given an opportunity to be heard; and

WHEREAS, Article 8, Section 8-104 (C) (3) of the Coral Gables Zoning Code states that “if after a public hearing the Historic Preservation Board finds that the proposed local historic landmark or proposed local historic landmark district meets the criteria set forth in Section 8-103, it shall designate the property as a local historic landmark or local historic landmark district;” and

WHEREAS, 1221 Milan Avenue, a single-family residence, was one of eight homes commissioned for Milan Avenue by City founder George Merrick in 1923. Designed by noted architect Lewis Brumm, it was built during the City’s initial boom years in accordance with founder Merrick’s plan for a Mediterranean-inspired city based on Garden City and City Beautiful precepts; and

WHEREAS, 1221 Milan Avenue represents Merrick’s incorporation of Garden City precepts to provide affordable middle-class housing. Milan Avenue was specifically developed with financing from Merrick as a street of ‘moderately priced attractive houses.’ These modest homes were smaller in size but were built with the same high-quality construction and features as other structures that shaped the new city in the early 1920s. The houses on Milan Avenue are amongst the earliest of what are now known as Coral Gables Cottages; and

WHEREAS, 1221 Milan Avenue retains its historic integrity and significantly contributes to the historic fabric of the City of Coral Gables and is part of the collection of quality residences that contributes to the story and the City’s sense of place over time; and

WHEREAS, 1221 Milan Avenue satisfies the “historical, cultural significance criteria” as stated in Article 8, Section 8-103 of the Coral Gables Zoning Code because it exemplifies the historical, cultural, political, economic, or social trends of the community; and

WHEREAS, 1221 Milan Avenue satisfies the “architectural significance criteria” as stated in Article 8, Section 8-103 of the Coral Gables Zoning Code because it portrays the environment in an era of history characterized by one (1) or more distinctive architectural styles; and it embodies those distinguishing characteristics of an architectural style, or period, or method of construction; and

WHEREAS, it is the policy of the City of Coral Gables to preserve its architectural heritage by designating certain properties as local historic landmarks; and

WHEREAS, upon due and proper consideration having been given to the matter it is the opinion of this Board that the subject property meets the criteria set forth in Article 8, Section 8-103 of the Zoning Code of the City of Coral Gables, and approved that it be designated as a “Local Historic Landmark; and

WHEREAS, Local Historic Designation supports the Goals, Objectives, and Policies of the City's Comprehensive Plan, specifically to "preserve and promote the recognition of structures, sites, manmade or natural landscape elements, works of art or integrated combinations thereof, which serve as visible reminders of the history and cultural heritage of the City;" and

WHEREAS, the legal description of the property is as follows: Lot 9, Block 39, Coral Gables Granada Section, according to the Plat thereof, as recorded in Plat Book 8, at Page 113 of the Public Records of Miami-Dade County, Florida; and

WHEREAS, a Designation Report, Case File LHD 2022-007, prepared by the Historic Landmark Officer containing information on the historical, cultural significance and architectural significance of the property and which incorporates a Review Guide for use as a reference in determining the impact of future building permits, shall by reference be made part of this resolution; and

WHEREAS, a motion to approve the historic designation of the subject property was offered by Michael Maxwell and seconded by Peggy Rolando and upon a poll of the members present the vote was as follows:

NOW THEREFORE BE IT RESOLVED, by the Historic Preservation Board of the City of Coral Gables that the Historic Preservation Board on September 21, 2022, has designated 1221 Milan Avenue, Coral Gables, Miami-Dade County, Florida as a Local Historic Landmark pursuant to the City of Coral Gables Historic Preservation Ordinance – Article 8 of the Coral Gables Zoning Code and the property is subject to all rights and privileges and requirements of that ordinance.

BE IT FURTHER RESOLVED, that this designation is predicated on all the above recitations, which are incorporated herein, being true and correct, but if any section, part of section, paragraph, clause, phrase or word of this Resolution is declared invalid, the remaining provisions of this Resolution shall not be affected.

Any aggrieved party desiring to appeal a decision of the Historic Preservation Board shall, within ten (10) days from the date of such decision, file a written Notice of Appeal with the City Clerk.
