## **RESOLUTION NO. 2024-101**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE ACCEPTANCE OF A KEEP AMERICA BEAUTIFUL CIGARETTE LITTER PREVENTION PROGRAM GRANT IN THE VALUE AMOUNT OF \$5,000 TO BE PUT TOWARDS THE "KEEP CORAL GABLES BEAUTIFUL" CIGARETTE LITTER PREVENTION PROGRAM; AUTHORIZING EXECUTION OF THE GRANT CONTRACT; AND AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2023-2024 ANNUAL BUDGET TO RECOGNIZE THE \$3,848 GRANT AS REVENUE AND TO APPROPRIATE SUCH FUNDS TO PUT TOWARD THE COST OF THE PROGRAM.

**WHEREAS,** the City was awarded a Keep America Beautiful Cigarette Litter Prevention Program Grant for the Keep Coral Gables Beautiful (KCGB) program in the value amount of \$5,000; and

**WHEREAS,** the grant is comprised of \$3,848 cash award, 2 mounted cigarette receptacles valued at \$1,152, and 400 pocket ashtrays and 200 auto ashtrays as an in-kind donation for KCGB's use; and

**WHEREAS,** an amendment to the Fiscal Year 2023-2024 Annual Budget is required to recognize the \$3,848 grant as revenue and to appropriate the funds towards the cost of the program;

## NOW, THEREFORE, BE IT RESOLVED BY CITY COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA THAT:

- **SECTION 1.** That the forgoing "WHEREAS" clauses are hereby confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption herein.
- **SECTION 2.** That the City Commission does hereby authorize the acceptance of the Keep America Beautiful Cigarette Litter Prevention Program Grant in the amount of \$5,000 towards the Keep Coral Gables Beautiful program.
- **SECTION 3.** That the City Commission does hereby authorize the execution of the grant contract with Keep America Beautiful.
- **SECTION 4.** That the City Commission does hereby authorize an amendment to the Fiscal Year 2023-2024 annual budget to recognize the \$3,848 grant as revenue and to appropriate the funds to be used towards the cost of the program.

SECTION 5. That this Resolution shall become effective upon the date of its passage and adoption herein.
