Mr. Holmes: Thank you very much. I know that all of you at City Hall care about the city and so I'll hope you'll take my comments to heart, because its somewhat troubling and scary. I've learned from the Police-Fire Union, who I highly commend for helping bring this to people's attention that there have been no, and this gets back to Gables Station now, because this relates, if anyone is listening from Gables Station, I hope you listen carefully. Over the past 30 years, we've had no additional hires for firefighters despite the fact that there have been at least 50 buildings during this time, major buildings, either already built long since and open long since, or like Gables Station coming on board. So, if we look at the people who will be residing in Gables Station, what I submit to you and this is new to me, so I don't want to pretend otherwise, but I've researched this with very learned people, former Commissioners, we don't have enough firefighters and so, we have a public safety issue. Please, Mayor Valdes-Fauli, Mr. Iglesias, all of you, we are in, I believe, that we need a minimum of 9 probably 11 more firefighters to bring us fully up to code. This is a very serious situation. Please hire more firefighters. Take care of the people at Gables Station and all around the city.

Vice Mayor Lago: Thank you sir, we appreciate your comments, they'll be taken into consideration. Madam City Attorney, do you want to move onto F-8?
