DRAFT RESOLUTION

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE PROCUREMENT OFFICER TO WAIVE THE COMPETITIVE BID PROCESS OF THE PROCUREMENT CODE PURSUANT TO SECTION 2-691 ENTITLED "SPECIAL PROCUREMENT/BID WAIVER" FOR THE LEASE OF ELEVEN (11) 2020 FLHP HARLEY-DAVIDSON MOTORCYCLES FROM PETERSON'S HARLEY-DAVIDSON OF MIAMI, LLC., FOR A TWO (2) YEAR PERIOD.

WHEREAS, the City's current lease for the 2018 Harley-Davidson FLHP motorcycles from Peterson's Harley-Davidson of Miami, LLC will expire in August 14, 2020; and

WHEREAS, Peterson's Harley-Davidson of Miami proposes a new lease agreement to replace the eleven (11) 2018 Harley-Davidson motorcycles for the Police Department's Special Enforcement Division/Motor Unit with new 2020 models; and

WHEREAS, the 2020 models cost \$625 per motorcycle, per month, for a two (2) year period in the amount of \$165,000.00 commencing upon the City's acceptance of delivery of the last new motorcycle under the new agreement; and

WHEREAS, Section 2-691 of the Procurement Code entitled "Special Procurement/Bid Waiver" authorizes the Procurement Officer to initiate a special procurement/bid waiver when an unusual or unique situation exists that makes the application of all requirements of competitive sealed bidding or competitive sealed proposal contrary to the public interest; and

WHEREAS, Section 2-585 of the Procurement Code entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards.

NOW THEREFORE BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts the recommendation of the Chief Procurement Officer pursuant to Section 2-691 of the Procurement Code entitled "Special Procurement/Bid Waiver," for the lease eleven (11) 2020 Harley-Davidson FLHP motorcycles from Peterson's Harley-Davidson of Miami, LLC., for a two (2) year term with a total lease amount of \$165,000 for all leased motorcycles, subject to final approval and execution of a lease agreement by City staff.

SECTION 3. This resolution shall become effective upon the date of its adoption herein.
