ON SUNDAY, MARCH 6, 2022 ON MIRACLE MILE FROM DOUGLAS TO LEJEUNE AS PART OF THE CARNAVAL ON THE MILE, SUBJECT TO FLORIDA DEPARTMENT OF PROFESSIONAL REGULATION REQUIREMENTS.

**BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the Kiwanis Club of Little Havana be approved to celebrate CARNAVAL ON THE MILE in Coral Gables. This request is to serve alcoholic beverages during the celebration and is in compliance with the laws of the State of Florida.

**SECTION 2.** CARNAVAL ON THE MILE will take place from 10:00 a.m. to midnight on Saturday, March 5, 2022, and from 10:00 a.m. to 10:00 p.m. on Sunday, March 6, 2022 at Miracle Mile- Douglas Road/ LeJeune Avenue.

**SECTION 3.** The Kiwanis Club of Little Havana is approved to sell alcoholic beverages from 12 p.m. to midnight on Saturday, March 5, 2022 and from 12 p.m. to 10 p.m. on Sunday, March 6, 2022.

**SECTION 4.** The event is family oriented with music and an art festival.


**SECTION 5.** This request has been reviewed by the City's Special Events Committee.


