RESOLUTION NO. 2020-64

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION TO WAIVE THE COMPETITIVE PROCESS OF THE PROCUREMENT CODE FOR THE PURCHASE OF EQUIPMENT FOR THE POLICE DEPARTMENT FROM SPECIAL OPS TACTICAL AS A “SOLE SOURCE PROCUREMENT,” PURSUANT TO SECTION 2-689 OF THE CITY’S PROCUREMENT CODE.

WHEREAS, the Police Department’s inventory under the Rifle Program is outdated and requires both replacement and expansion; and

WHEREAS, the equipment associated with this program provides the Police Department with essential Public Safety capabilities; and

WHEREAS, the cost for the replacement and expansion of this equipment totals \$72,875.00; and

WHEREAS, the Police Department evaluated equipment from multiple vendors and selected specific equipment from Special Ops Tactical; and

WHEREAS, Special Ops Tactical is the patent holder and sole provider of the selected equipment; and

WHEREAS, Section 2-689 of the Procurement Code, entitled “Sole Source Procurement” authorizes an award without competitive bids when there is only one source available to fulfill the needs of the City; and

WHEREAS, Section 2-585 of the Procurement Code, entitled “Authority” authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts the recommendation and authorizes the City Manager to waive the competitive bid process of the Procurement Code and purchase equipment from Special Ops Tactical in the amount of \$72,875.00, pursuant to Section 2-689 of the City's Procurement Code.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.


