## **DRAFT RESOLUTION \_\_\_\_\_**

### **RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD A CONTRACT FOR GYMNASTIC PROFESSIONAL SERVICE TO GYM KIDZ, INC. PURSUANT TO SECTION 2-828 OF THE PROCUREMENT CODE AND REQUEST FOR PROPOSAL (RFP) 2010.02.19 FOR AN INITIAL THREE (3) YEAR TERM WITH AN OPTION TO RENEW FOR TWO (2) ADDITIONAL ONE (1) YEAR PERIODS.**

**WHEREAS**, on February 19, 2010, the Procurement Division of Finance formally advertised, issued and distributed the Gymnastics Professional Services Request for Proposal (RFP) 2010.02.19; and

**WHEREAS**, on March 25, 2010, responses to the Gymnastics Professional Services RFP submitted by Gym Kidz, Inc. and Tumblebees Gymnastics were publicly opened; and

**WHEREAS**, on April 26, 2010, a Selection Committee completed their evaluation based on the following: qualifications including degrees, licenses and certifications; program proposal and added value opportunities, staffing allocations and qualifications; business history, performance and references; and percentage of earnings to the City; and

**WHEREAS**, the Selection Committee ranked Gymkidz, Inc. as the most responsive responsible proposer ; and

**WHEREAS**, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts; and

### **NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**Section 1.** The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**Section 2.** That the City Commission accepts the recommendation of the Chief Procurement Officer to award a contract for Gymnastic Professional Service to Gym Kidz, Inc. pursuant to Section 2-828 of the Procurement Code and Request for Proposal (RFP) 2010.02.19 for an initial three (3) year term with an option to renew for two (2) additional one (1) year periods.

**Section 3.** That all Resolutions or parts of Resolutions inconsistent with, or in conflict herewith, shall be and are hereby repealed insofar as there is conflict or inconsistency.

**Section 4.** That this Resolution shall become effective upon the date of its adoption herein.
