RESOLUTION NO. 2008-116

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE CITY MANAGER TO EXECUTE A JOINT PROJECT AGREEMENT BETWEEN THE FLORIDA DEPARTMENT OF TRANSPORTATION AND THE CITY OF CORAL GABLES, FLORIDA (CONTRACT NUMBER AP 783 – FINANCIAL NUMBER 2523117801), FOR ONE (1) YEAR AND AN ADDITIONAL TWO (2) ONE (1) YEAR ANNUAL RENEWALS, FOR MAINTENANCE OF US HIGHWAY #1, BIRD ROAD AND RED ROAD WITHIN CORAL GABLES, FLORIDA

WHEREAS, portions of State of Florida designated roadways (US Highway #1, Bird Road, and Red Road) are located within the City of Coral Gables; and

WHEREAS, these roadways contain median and roadside areas that require maintenance; and

WHEREAS, the State of Florida and the City recognizes the need for entering into an agreement designating and setting forth the responsibilities of each party with regard to the maintenance of the landscaping associated with these areas;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The forgoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission does hereby authorize the City Manager on behalf of the City to execute a one (1) year Joint Project Agreement (Contract Number AP 783 – Financial Number 2523117801) and two (2) one (1) year annual renewal contracts with the Florida Department of Transportation for the maintenance of US #1, Bird Road and Red Road within Coral Gables.

SECTION 3. That the executed agreement shall be made a part of this resolution and kept on file in the office of the City Clerk.

SECTION 4. That this resolution shall become effective upon the date of its passage and adoption herein.


