Mayor Lago introduced the Proclamation declaring May 19-25, 2024, as "Emergency Medical Services Week" in Coral Gables and Commissioner Menendez read the proclamation. Fire Chief de la Rosa made the presentation but not before introducing the city's Medical Director for the past 17 years, Dr. Frederick Keroff, an emergency certified physician who is the cornerstone of EMS from its inception and a great guidance to their organization and success and even during COVID 19 he took on being their medical authority. Fire Chief de la Rosa then gave a brief history of EMS (Emergency Medical Services) week which was introduced by then President Ford, and while it is thought that it has always been around it is a 50 year industry which began as an experiment to mediate deaths due to motor vehicle accidents and over these years, there has been a momentous quantum leap from what EMS was to where they are today. He then thanked the Mayor and City Commission for the recognition.

Mayor Lago introduced Agenda Item A-5 Presentation of the Coral Gables Fire Department Jim Hirschman Award and Fire Chief de la Rosa made the presentation in which each year during EMS week they recognize one of their rescue crews that performed above and beyond the call of duty and had a significant impact on the community or a certain patient. Division Fire Chief Jones in charge of EMS was then asked to introduce this year's fire crew. Division Fire Chief Jones stated that it is a pleasure and a privilege to give the inaugural Jim Hirschman Award. This Award is given to individuals who have excelled in their medical performances as the Fire Chief stated. Jim Hirschman was a medical doctor who served as the Fire Department's medical professional for over 20 years and his innovation is all over the world regarding EMS. He then asked Dr. Frederick Keroff to say a few words about who Dr. Hirschman was. Dr. Keroff stated that Dr. Hirschman was a cardiologist by training, an innovator who brought his Emergency Room knowledge from the hospital to the paramedics so that when they arrived at an accident, they could do all those things which is taken for granted. He then thanked the Mayor and City Commission for honoring Dr. Hirschman with an award given to the paramedics being honored. This Award given to these individuals was about an incident which involved a City of Miami employee that they were called to transport from Coral Gables Hospital to another facility. While at the hospital, the individual went into cardiac arrest, and they

were able to bring this individual back to life. He then listed the names of the recipients, namely Lieutenant Carlo Milto, Lieutenant Christina Muslera and Firefighter Emilio Martinez (not in attendance) and thanked the Mayor and City Commission. Lt. Milto stated that the call was something that he had never seen in his career and is appreciative that he had a chance to make a difference in the community and that person's life and is everyday touching people's lives. Dr. Keroff stated that the paramedics took over the CPR and resuscitated the patient who is now not only alive but fully functional now. It is a remarkable feat and said hats off to the recipients of the Award.

He stated that today they are losing two incredible individuals in the city. He then read the proclamation [applause]. Mr. Kinney thanked the Mayor for the recognition and said that this concept or obsession of retirement confuses him but helps him to understand the words of a great American-Fred Rogers who once said “often when you think you’re at the end of something, you’re at the beginning of something else,” and so life is life and he doesn’t know that he is ever going to want to stop living and he can promise us that the passion he has had for his responsibilities at the city for the last 18 years, on June 3rd when he wakes up that passion will be there, and it maybe for something else like his 1, 2, and 3 year old granddaughters, but that passion will be there and what he is doing. He stated that the hardest thing is leaving the team that the city has because there are people he has been in the trenches in for 18, 10, 2 years and a few for just two months or even weeks but it is easy for him to be passionate about what he is doing because he is working with people who are passionate about what they are doing and that is the only difficult part of this because change is good, it is normal. He keeps telling his wife that he is not retiring because he is not ready to stop - he is going to be doing something because Harper, Hazel and McKenna may eventually get tired of seeing their papa, but they are going to see him a lot. Mayor Lago thanked Mr. Kinney for his years of service to the city and they have worked together for 11 years and believe they have done a lot of good for the city and he has done a lot of incredible things. One of the things they have been complimented for as seen on the TPO is the city’s trolley service, how impeccable it was, ran on time and the city is the model. One of his legacies in which Mr. Kinney played an important role in is extending trolleys to Saturdays, new routes to the University of Miami, the Publix across US1, and their friends at Lola B. Walker Neighborhood even when faced with opposition but they got it done and it has paid significant dividends to a community that was underserved for a long time. Also, the modernization of parking in the city as it relates to the parking garages as well as to going paperless, using credit cards, and transitioning from coins to a more modern system and thanked him. An interesting point to note is that he works and lives in the city and when any official sent him an

email regarding something in the city, he was hands on, always willing to meet and have a conversation. He is known for walking up and down the downtown engaging with businessowners and residents and to him that is what governance is all about and that is something he has always admired; he took his job seriously and held himself to a higher standard and thanked him again for his years serving the City Beautiful and we are in a better place because he chose to join us. Mr. Kinney stated that he intends to continue walking downtown because his dog thinks she owns the city [laughter] and needs to go out and check things out. Also, the Parking and Mobility System in the City Beautiful is the envy of many, and they have launched way out of our weight class [phonetic] when you talk about how we move people and how we encourage the commerce in the central business district, and it is in good hands. Matt over the last year and a half has become an exceptional mobility service manager and bringing in Monica from the Beach (aka City of Miami Beach) is a great move for the city and only good things are going to happen. Jackson Rip Holmes thanked the Mayor and City Commission for the opportunity to pay tribute to Mr. Kinney in trying to bring to the city the safest parking garage in the entire country, the mobility hub soothing that is dear to his heart because it abuts his property, and it is going to be the safest in the country. Mr. Samuel Joseph, appearing on Zoom thanked the mayor for opportunity and stated that the city is going to be at a loss because Mr. Kinney is one of the most genuine human beings, he has had the pleasure of being around. He worked with Mr. Kinney when he was having issues with a particular school and parent drop off and getting parking tickets from a lot that was owned by a business and Mr. Kinney met with them, talked through the issue and determined how to persuade some angry parents residents and made the situation perfect for all concerned and all interactions with Mr. Kinney has been a pleasure and hope he enjoys Alaska and look forward to seeing him walking around town.
