## **RESOLUTION NO. 2025-366**

RESOLUTION OF THE CITY **COMMISSION** AUTHORIZING THE ACCEPTANCE OF A GRANT THE FLORIDA AGREEMENT NO. G3G23 WITH DEPARTMENT OF TRANSPORTATION (FDOT) IN THE AMOUNT OF \$196,000 TO BE PUT TOWARDS THE INCEPTION OF THE CORAL GABLES TROLLEY SOUTHERN LOOP SERVICE; AND AUTHORIZING THE CITY MANAGER TO **EXECUTE** THE **GRANT** AGREEMENT FOR SAID FINANCIAL ASSISTANCE.

**WHEREAS,** in an effort to enhance transportation connectivity in the southern corridor, the City applied and was awarded a competitive grant from the Florida Department of Transportation (FDOT) in the amount of \$196,000 for a new trolley service route; and

WHEREAS, this new service route will be known as the Trolley Southern Loop; and

**WHEREAS,** the Trolley Southern Loop is expected to provide access to key destinations such as the Underline, University of Miami, the Lennar Foundation Medical Center, medical offices and businesses along the Ponce de Leon corridor; and

**WHEREAS**, the Trolley Southern Loop will strengthen connections to the southern business district and the City of South Miami; and

**WHEREAS**, the total estimated cost of the project is \$400,000, with 49% (196,000) funded by FDOT and the remaining 51% (204,000) funded by the City's match; and

**WHEREAS,** the City Commission authorizes the City Manager to execute Grant Agreement No. G3G23, and any extensions, amendments, or modifications to the agreement;

## NOW, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

- **SECTION 1.** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.
- **SECTION 2.** The City Commission does hereby authorize the acceptance of Grant Agreement no. G3G23 by the Florida Department of Transportation.

**SECTION 3.** That the City Manager is authorized to execute Grant Agreement no. G3G23 and any subsequent extensions, amendments, or modifications to the agreement with the Florida Department of Transportation.

**SECTION 4.** That this Resolution shall become effective upon the date of its passage and adoption herein.
