A RESOLUTION OF THE CITY COMMISSION AUTHORIZING SATCHMO BLUES BAR AND GRILL, INC. TO HOST A TUESDAY EVENING EVENT AND TO SELL ALCOHOLIC BEVERAGES ON MARCH 17, 2020 FROM 4:00 P.M. TO 11:00 P.M. AT THE BIERHAUS PLAZA LOCATED AT 60 MERRICK WAY, DURING THE "ST. PATRICK'S DAY BLOCK PARTY" EVENT, SUBJECT TO FLORIDA DEPARTMENT OF PROFESSIONAL REGULATION REQUIREMENTS.

WHEREAS, the request has been reviewed by the City's Special Events Committee. The Special Events Committee approves events taking place Thursday thru Sunday, but due to St. Patrick's Day occurring on a Tuesday of the 2020 calendar year, this resolution is to authorize the event to be held on Tuesday, March 17, 2020; and

WHEREAS, all live music and entertainment will conclude by 10:00 p.m.;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That Satchmo Blues Bar and Grill, Inc. is permitted to sell alcoholic beverages on Tuesday, March 17, 2020 from 4:00 p.m. to 11:00 p.m. at the Bierhaus Plaza located at 60 Merrick Way, during the "St. Patrick's Day Block Party" event, subject to Florida Department of Professional Regulation Requirements.

SECTION 2. That this Resolution shall become effective upon the date of its passage and adoption herein.
