B. NEW BOARD MEMBER INTRODUCTION - RIGBY COLEMAN

Board Member Rigby Coleman introduced himself, providing a brief biography highlighting his finance background and his intention to bring a financial perspective to the Board.

D. PRESENTATION FROM THE CORAL GABLES ART CINEMA (Facilitated by Brenda Moe)

The Chairperson of the Coral Gables Cinema, Merlin Ebbert, introduced Brenda Moe, the Executive Director and Programming Director, to present the Cinema's 2023 Impact Report.

Ms. Moe's presentation covered the history of the Cinema and its activities from January 23 to December 23, including the screening of films on 35 and 70-millimeter film using a single screen. She also shared that the Cinema was the sole location in South Florida to screen Oppenheimer on 70-millimeter film, with 50 screenings of the film. Ms. Moe provided statistics and demographics of the Cinema's patrons and informed the Board about the funding sources, which include state, county, and city grants, individual and corporate donations, as well as revenue from ticket sales, memberships, venue rentals, and concession sales. Furthermore, Ms. Moe mentioned a reduction of \$100,000 in their state grant. She encouraged the Board to help spread the word about the Cinema, encouraging people to visit their website and sign up for their newsletter.

E. ASSET MANAGEMENT REPORT

Asset Manager Sardinias provided an update on Francesco stating that there are open and have received positive reviews on the food and the restaurant design.

Ms. Sardinias additionally provided an update on Sra. Martinez, stating that they were going through the licensing process with an expected opening date of late August.

Furthermore, Ms. Sardinias informed the Board that she had been negotiating a lease for the Granada Diner space with Ms. Rita Tennyson, as instructed by the City Commission. She also mentioned that a temporary certificate of occupancy is expected by the end of July, and a certificate of occupancy by the end of September. Ms. Sardinias provided the Board with the methodology used by the City to determine the rent price for spaces, stating that two market rate appraisals were conducted and, based on the appraisal amount, a rent price was determined.
