NOMINATION

It is an honor to nominate Officer Alexander Rodriguez for the Officer of the Month Award for February 2022, due to his law enforcement actions in reference to the apprehension of two grand theft auto subjects and the recovery of a stolen vehicle, narcotics, and drug paraphernalia (CGPD Case # 22-000838).

Case 22-000838 Synopsis:

On February 10, 2022, at approximately 10:21 am, CGPD Dispatch received an ALPR (Automated License Plate Reader) hit at SW 8 Street and Ponce De Leon Blvd (southbound) on a stolen white Toyota Highlander (FL tag KLPK96). Officer Alex Rodriguez responded and canvassed the area. At approximately 10:34 am, Officer Rodriguez located the stolen vehicle parked at the rear parking lot of ChateauBleau Hotel (1111 Ponce De Leon Blvd). Officer Rodriguez observed a female in the driver seat and a male standing outside the front right passenger side window communicating with her. Officer Rodriguez maintained a distance until backup officers arrived on scene. Once sufficient units arrived, both subjects, later identified as Vanity Alexus Morales (female) and Jorge Garcia (male), were detained for further investigation. A records check revealed both subjects had an extensive past.

Officer Rodriguez conducted a thorough examination of the vehicle and made confirmation that the vehicle was stolen out of unincorporated Miami-Dade County (MDPD Case PD22020804431) on February 8, 2022. Further investigation revealed the subjects were also in possession of narcotics and drug paraphernalia. Several items confiscated were indicative of drug use and drug sales. Due to these findings, both subjects were arrested and charged accordingly. Subsequently, Property Crimes Detectives conducted their follow-up investigation. Post Miranda Rights, MORALES advised she assumed the vehicle was stolen, but GARCIA invoked his rights.

Due to Officer Rodriguez's police actions, keen observation skills, and strong work ethic, he is most deserving of Officer of the Month for February 2022. It is without a doubt this arrest positively impacted the community, as well as both subjects, who were highly susceptible of overdosing on the potent/dangerous drugs in their possession.

NARRATIVE

On February 10, 2022, at approximately 1021 hours, CGPD dispatch received an LPR (License Plate Reader) hit on a stolen white Toyota Highlander (Tag # KLPK96). The LPR captured the vehicle traveling southbound on Ponce De Leon Boulevard from SW 8 Street. At approximately 1034 hours, I located a vehicle matching the description in the parking lot of 1111 Ponce De Leon Boulevard (Chateaubleau Hotel). During this time, I observed (Vanity Alexus Morales) Offender 1 occupying the driver seat of the vehicle while (Jorge Garcia) Offender 2 stood outside of the front right passenger side window as he was speaking with Ms. Morales.

I maintained my distance and waited for additional units to arrive. Officers Coleman (8420), DiCarlo (11548), Smith (7340), and J. Gonzalez (11416) arrived on scene at approximately 1038 hours. Once the additional units arrived on scene, contact was made with Ms. Morales and Mr. Garcia. I observed Mr. Garcia walking away from the vehicle as I approached on foot and detained him. He had two black backpacks slung around his person. Officer Dicarlo observed Ms. Morales placing her hands on the hood of the vehicle and detained her. As I walked to the rear of the vehicle, it displayed the same tag as provided by CGPD communications. The vehicle VIN number matched the VIN number of the NCIC/FCIC stolen notification. I initiated a pat down of Mr. Garcia for officer safety and asked him where the keys to the vehicle were. He stated the keys were in his front left pocket and told me I could remove them; the keys were retrieved. Mr. Garcia and Ms. Morales were separated. Ms. Morales was placed into Officer Dicarlo's patrol vehicle and Mr. Garcia was placed into Officer Coleman's patrol vehicle.

Miami Dade County Police confirmed with CGPD communications that the vehicle was still actively stolen as of 02/8/2022 (MDPD case PD220208044311). CGPD Crime Scene employee Sierra (L901) responded to the scene and took pictures of the vehicle. Mr. Garcia and Ms. Morales were placed under arrest. A search incident to arrest of the single sling black book bag located on Mr. Garcia revealed a clear baggie containing an unknown blue powdery substance that was located inside the top outer pocket. A search of the double sling black bookbag located on Mr. Garcia revealed a digital scale, multiple clear individual baggies, a small clear baggie containing an unknown crystalized rock substance (Suspected meth), a small baggie containing unknown small broken down crystalized substances (Suspected meth), a white capsule shaped pill marked (300) identified by pillidentifier.com as Quetiapine Fumarate, a small round pouch containing a small clear wrapper with an unknown white powdery residue on it (Suspected cocaine), and a small black zipper bag containing eight medical capped syringes.

Officer Dicarlo transported Ms. Morales to CGPD station and Officer Coleman transported Mr. Garcia to the CGPD station. CGPD detectives Taha (ID 10443) and J. Gonzalez (ID 10924) interviewed Ms. Morales first and read her Miranda rights at approximately 1155 hours. Post Miranda, she stated her female friend "Daytona" had dropped off the stolen vehicle to her at the date of this incident at the Chateaubleau Hotel (1111 Ponce de Leon Blvd). She did not provide further information about her friend and stated she had a feeling the vehicle was stolen. Ms. Morales further stated she had no knowledge about the narcotics found inside the mentioned book bags but stated the single slinged black backpack belonged to her and the other backpack did not. The single slinged backpack also contained women makeup products.

CGPD detectives then interviewed Mr. Garcia and read him his Miranda rights at approximately 1232 hours. He did not wish to answer any questions and remained silent.

Ms. Morales mentioned to me she was missing a purse that we did not have. At approximately 1541 hours, Officer Baez (ID 11470) was dispatched to the 800-Block of Ponce de Leon Blvd (3 blocks away from 1111 Ponce de Leon Blvd) in reference to a found purse on the ground. The purse was white in color with dots all around. Ms. Morales had described her missing purse as white with dots all around. The contents of the purse revealed an empty wallet, one condom, two clear paraphernalia pipes with burnt ends, one small baggie with an unknown small white rock substance, two clear baggies with unknown white powdery residue, and a medical syringe loaded with a unknown clear liquid substance. I showed Ms. Morales the purse and asked her if it was her missing purse; she immediately stated "Yes, that's my purse!". She confirmed the items in the purse belonged to her but denied the narcotics and paraphernalia.

Downtown towing responded to 1111 Ponce de Leon Blvd to impound the vehicle while Officer J.D Gonzalez (ID 11416) stayed with the vehicle.

At approximately 1740 hours, while Ms. Morales was inside the CGPD holding cell, she stated to Officer Dicarlo (11548) "I am going to get Xanaxed up and come back and shoot up the police station." She then stated, "I am going to hire a hitman to come shoot you cops."

Ms. Morales and Mr. Garcia were transported to TGK via CGPD processing. CGPD SIS Det. A. Johnson was notified of the incident. MDPD Operator Mathis removed the stolen vehicle from NCIC/FCIC as stolen status.
