RESOLUTION NO. 2010-177

RESOLUTION AUTHORIZING AN AMENDMENT TO THE EXISTING CONTRACT WITH SOUTH FLORIDA MAINTENANCE SERVICES, INC., ENTITLED "LANDSCAPE MAINTENANCE OF VARIOUS LOCATIONS IN THE CITY OF CORAL GABLES, FLA. DPS #2001-01", FOR THE PURPOSE OF ADDING THE MAINTENANCE OF U.S. HIGHWAY 1 AND MACFARLANE LINEAR PARK.

WHEREAS, an existing contract that expires September 30, 2011, and is entitled "Landscape Maintenance of Various Locations in the City of Coral Gables, Fla. DPS #2001-01" between the City of Coral Gables and South Florida Maintenance Services, Inc., allows for the addition of sites to be maintained under the contract; and

WHEREAS, a separate contract with South Florida Maintenance Services, Inc. for the maintenance of U.S. Highway 1 and MacFarlane Linear Park will expire on August 31, 2010; and

WHEREAS, South Florida Maintenance Services, Inc. has agreed to maintain U.S. Highway 1 and MacFarlane Linear Park as part of the "Landscape Maintenance of Various Locations in the City of Coral Gables, Fla. DPS #2001-01" contract, for \$121,250.00 per year, which is a 11.4% reduction from the previous cost of \$136,850.00/year;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

SECTION 1. That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission does hereby authorize the execution of an amendment to the contract with South Florida Maintenance Services, Inc., entitled "Landscape Maintenance of Various Locations in the City of Coral Gables, Fla. DPS #2001-01", for the purpose of adding U.S. Highway 1 and MacFarlane Linear Park as areas to be maintained under that contract, for a cost of \$121,250.00 per year.

SECTION 3. That the commencement of service provided for U. S. Highway 1 and MacFarlane Linear Park as added locations to the "Landscape Maintenance of Various Locations in the City of Coral Gables, Fla. DPS #2001-01" contract, shall be September 1, 2010, and said service shall terminate on September 30, 2011.

SECTION 4. That the U.S. Highway 1 and MacFarlane Linear Park sites shall be maintained using a unique set of specifications identical to those previously used for these areas and payments for the added work shall be made in accordance with the formula set forth in the original U.S. Highway 1, MacFarlane Linear Park contract.

SECTION 5. That this resolution shall become effective upon the date of its passage and adoption herein.
