**RESOLUTION OF THE CITY COMMISSION OF
CORAL GABLES AMENDING RESOLUTION
2009-233 WHICH ESTABLISHED FEES FOR
VARIOUS LICENSES, PERMITS, SERVICES,
AND PENALTIES BY THE CITY OF CORAL
GABLES, PROVIDING FOR SEVERABILITY,
AND AN EFFECTIVE DATE.**

WHEREAS, Resolution No. 2006-187, passed and adopted by the City Commission on October 10, 2006 and subsequently amended by Resolution 2006-211 on December 12, 2006, Resolution 2007-153 on June 26, 2007, Resolution 2007-245 on October 23, 2007 and Resolution 2008-201 (As Amended) on November 18, 2008, and Resolution No. 2009-322 on November 17, 2009 established fees for various licenses, permits, services and penalties by the City of Coral Gables; and

WHEREAS, any subsequent increases or additions to the fees contained in this resolution shall be established by the City Commission by amending this resolution; and

WHEREAS, the City Commission has determined that it is necessary to recover more of the City's cost of providing these services.

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF
THE CITY OF CORAL GABLES:**

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.




