

# **CITY OF CORAL GABLES, FLORIDA**

## **ORDINANCE NO. 2009-42**

AN ORDINANCE AMENDING CHAPTER 26, ENTITLED "EMERGENCY SERVICES" IN PARTICULAR, SECTION 26-1 "FEES FOR EMERGENCY RESCUE SERVICES" AND CHAPTER 30, ENTITLED "FIRE PREVENTION AND PROTECTION," IN PARTICULAR, SECTION 30-6 "FEES FOR EMERGENCY RESCUE SERVICES" ALLOWING FOR FEES TO BE ASSESSED TO ALL PERSONS TRANSPORTED VIA CITY FIRE DEPARTMENT VEHICLE; REPEALING ALL ORDINANCES INCONSISTENT HERewith AND PROVIDING FOR AN EFFECTIVE DATE.

### **BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That Chapters 26 and 30 of the "Code of the City of Coral Gables," both entitled "Fire Prevention and Protection," shall be and are hereby amended to read as follows:

#### **Section 26-1. Fees for Emergency Rescue Services**

The fees which shall be assessed for persons transported via fire department vehicle shall be in the amount established by the City Commission.

#### **Section 30-6. Fees for Emergency Rescue Services**

The fees which shall be assessed for persons transported via fire department vehicle shall be in the amount established by the City Commission.

### **SECTION 2. SEVERABILITY**

If any section, sentence, clause, or phase of this Ordinance is held to be invalid or unconstitutional by any court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this Ordinance.

### **SECTION 3. REPEALER**

All Ordinances or parts of Ordinances that are inconsistent or in conflict with the provisions of this Ordinance are repealed.

#### SECTION 4. CODIFICATION

It is the intention of the Commission of Coral Gables, Florida, that the provisions of this Ordinance shall become and be made a part of the City of Coral Gables Code of Ordinances; and that the sections of this Ordinance may be renumbered or relettered to accomplish such intention, and the word "Ordinance" may be changed to "Section:", "Article", or such other appropriate word or phrase in order to accomplish such intentions.

#### SECTION 5. EFFECTIVE DATE

This Ordinance shall become effective on October 1, 2009.
