Dear Mr. Riel:

We are requesting the following amendment to the City of Coral Gables ("City") Zoning Map:

1. A map amendment to include properties that have been used for University use, but have not been so designated on the City's Zoning Map.

A more detailed description of said amendment follows.

1. Proposed Zoning Map Change – University Campus District (UCD)

This amendment, further described in Exhibit "A" attached hereto, changes two buildings that have been used for University use, and have historically been reflected in all Campus plans and studies, and rezones them to University Campus District (UCD). While the Comprehensive Plan designation for these properties is presently "Commercial", as indicated in our application, we are in the process of having the designation changed to "University Campus", in order that both the land use designation and the zoning be consistent with the current use of the properties.

Based upon the foregoing, we look forward to your favorable recommendation to the proposed Zoning Map amendment.





Proposed Zoning Map








