RESOLUTION NO. 2010-110

RESOLUTION AUTHORIZING THE EXECUTION OF AN INTERLOCAL AGREEMENT WITH MIAMI-DADE TRANSIT AGENCY FOR FEDERAL FUNDING PASS-THROUGH ARRANGEMENTS WITH THE AMERICAN RECOVERY AND REINVESTMENT ACT (ARRA) OF 2009 TO PURCHASE TROLLEY(S) TO OPERATE THE CITY OF CORAL GABLES CIRCULATOR SERVICE.

BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

WHEREAS, Miami-Dade Transit Agency (MDT) is the recipient of a grant from the federal Transit Administration pursuant to the American Recovery and Reinvestment Act (ARRA) of 2009, project FL-96-X028-1, in the amount of \$5,255,527.00; and

WHEREAS, this grant provides \$437,423.00 for the purchase of shuttle buses with a vintage trolley configuration for the City of Coral Gables; and

WHEREAS, some of the existing trolleys within the Coral Gables fleet are nearing the end of their useful service life; and

WHEREAS, an Interlocal Agreement is required authorizing MDT to procure trolley(s) on behalf of the City of Coral Gables;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution upon adoption hereof.

SECTION 2. That the City Commission does hereby accept the grant of \$437,423.00 from the American Recovery and Reinvestment Act ARRA of 2009, providing for the purchase of trolley(s).

SECTION 3. That the City Manager is authorized to enter into an Interlocal Agreement providing Federal funding pass-through arrangements for funds awarded pursuant to the American Recovery and Reinvestment Act (ARRA) of 2009.

SECTION 4. That this resolution shall become effective upon the date of its passage and adoption herein.
