#### AMENDMENT NO. 3 TO AGREEMENT NO. C2207 BETWEEN

# FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION AND

### CITY OF CORAL GABLES

This Amendment to Agreement No. C2207 (Agreement), as previously amended, is made by and between the Department of Environmental Protection (Department), an agency of the State of Florida, and the City of Coral Gables (Grantee), on the date last signed below.

WHEREAS, the Department entered into the Agreement with the Grantee for Sanitary Sewer Coastal Rehabilitation (Project), effective June 9, 2023; and,

WHEREAS, the Grantee has requested an extension of the Agreement due to delays in the preparation of bid documents and bid phase process; and,

WHEREAS, the parties have agreed to amend the Agreement as set forth herein.

NOW THEREFORE, the parties agree as follows:

- 1. Section 3. of the Standard Grant Agreement is hereby revised to change the Date of Expiration to July 31, 2026. The Department and the Grantee shall continue to perform their respective duties during this extension period pursuant to the same terms and conditions provided in the Agreement.
- 2. Attachment 3-B, Revised Grant Work Plan, is hereby deleted in its entirety and replaced with Attachment 3-C, Revised Grant Work Plan, as attached to this Amendment and hereby incorporated into the Agreement. All references in the Agreement to Attachment 3-B shall hereinafter refer to Attachment 3-C, Revised Grant Work Plan.
- 3. Attachment 5, Special Audit Requirements, is hereby deleted in its entirety and replaced with Attachment 5-1, Revised Special Audit Requirements, as attached to this Amendment and hereby incorporated into the Agreement. All references in the Agreement to Attachment 5 shall hereinafter refer to Attachment 5-1, Revised Special Audit Requirements.
- 4. Exhibit A-1, Progress Report Form, is hereby deleted in its entirety and replaced with Exhibit A-2, attached hereto and made a part of the Agreement. All references in the Agreement to Exhibit A-1 shall hereinafter refer to Exhibit A-2.
- 5. All other terms and conditions of the Agreement remain in effect. If and to the extent that any inconsistency may appear between the Agreement and this Amendment, the provisions of this Amendment shall control.

# **ATTACHMENT 3-C**

#### REVISED GRANT WORK PLAN

- I. PROJECT TITLE: City of Coral Gables, Sanitary Sewer Coastal Bay Service Area Rehabilitation Phase I
- II. PROJECT LOCATION(S): The Project will be located in the City of Coral Gables, in the Cocoplum, Gables Estates and Gables by the Sea neighborhoods. The Project sites are located in the vicinity of the Goral Gables Waterway Canals and Biscayne Bay. Lat/Long: (25.7491, -80.2635).
- III. PROJECT BACKGROUND: To prevent sanitary sewer pipe exfiltration and infiltration located in the areas of Cocoplum, Gables Estates and Gables by the Sea neighborhoods, the City of Coral Gables (Grantee) aims to repair and/or replace its existing gravity sanitary sewer pipe system in the areas of Cocoplum, Gables Estates and Gables by the Sea neighborhoods that are located in the vicinity of the Coral Gables Waterway Canals and Biscayne Bay. Due to age and substandard pipe material, the existing sewer system is currently experiencing pipe exfiltration and infiltration resulting in volumes of untreated wastewater that become the source for groundwater and surface water pollution, ultimately affecting water quality and the natural environment. This project is necessary to reduce nutrient pollution and improve the water quality in groundwater and surrounding surface water bodies. Additionally, this project will also improve the reliability of the City's sewer gravity system in serving the residents.
- IV. PROJECT DESCRIPTION: The Grantee will repair and/or replace its existing gravity sanitary sewer pipe system in the areas of Cocoplum, Gables Estates and Gables by the Sea neighborhoods that are located in the vicinity of the Coral Gables Waterway Canals and Biscayne Bay. The grantee will rehabilitate approximately 30,000 Linear Feet (L.F.) of sanitary gravity sewer pipe and associated manholes by performing cement grouting, slip lining, cured-in-place pipe, fold and form pipe, pipe bursting, and point (spot) repair or minor pipe replacement in some cases. This will help to reduce the leakage of wastewater out of the sanitary gravity sewer system that occurs due to cracked or damaged pipes and manholes. The City intends to publicly bid this project and enter into an agreement with a Contractor to complete the work.

The Grantee anticipates that the funding under this Agreement will result in a fully completed project.

The DEP Grant Funds associated with this Agreement were awarded based on local contributions pledged towards the total project costs: \$500,000 from the City of Coral Gables. A summary of the local contributions will be required in the Final Quarterly Progress Report, and financial supporting documentation shall be provided upon request.

V. TASKS: All deliverables shall be submitted electronically unless otherwise indicated and should be submitted prior to the expiration of the grant agreement.

## **Task 1: Construction**

**Deliverables:** The Grantee will repair and rehabilitate approximately 30,000 L.F. of sanitary gravity sewer pipe in accordance with the construction contract documents.

**Documentation:** The Grantee will submit: 1) a copy of the final design; 2) a signed summary of activities completed for the period of work covered in the payment request, using the format provided by the

Department's Grant Manager. Upon request by the Department's Grant Manager, the Grantee will provide additional supporting documentation relating to this task.

**Performance Standard:** The Department's Grant Manager will review the documentation to verify that the deliverables have been completed as described above. Upon review and written acceptance by the Department's Grant Manager, the Grantee may proceed with payment request submittal.

**Payment Request Schedule:** The Grantee may submit a payment request for cost reimbursement no more frequently than monthly.

**PROJECT TIMELINE & BUDGET DETAIL BY TASK:** The tasks must be completed by the corresponding task end date. Cost reimbursable grant funding must not exceed the budget amounts as indicated below. For any Task with a Budget Category of Contractual Services, the Grantee shall submit a copy of the executed subcontract to the Department prior to submitting any invoices for subcontracted work.

Note that, per Section 8 of Attachment 1 in the Agreement, authorization for continuation and completion of work and any associated payments may be rescinded, with proper notice, at the discretion of the Department if the Legislature reduces or eliminates appropriations. Extending the contract end date carries the risk that funds for this project may become unavailable in the future. This should be a consideration for the Grantee with this and future requests for extension.

The recipient further agrees to comply and cooperate with any inspections, reviews, investigations, or audits deemed necessary by the Chief Financial Officer (CFO) or Auditor General.

#### **AUDITS**

#### PART I: FEDERALLY FUNDED

This part is applicable if the recipient is a State or local government or a non-profit organization as defined in 2 CFR §200.330

- 1. A recipient that expends \$1,000,000 or more in Federal awards in its fiscal year, must have a single or program-specific audit conducted in accordance with the provisions of 2 CFR Part 200, Subpart F.
