RESOLUTION NO. 2023-343

A RESOLUTION OF THE CITY COMMISSION DIRECTING CITY STAFF TO INCLUDE A SCHEDULE(S) IN EACH VERSION OF THE CITY BUDGET PRESENTED TO THE CITY COMMISSION FOR APPROVAL OUTLINING THE CHANGES IN SALARIES BY DEPARTMENT FROM THE PREVIOUS VERSION OF THE BUDGET PRESENTED TO THE CITY COMMISSION.

WHEREAS, in accordance with those procedures set forth in state law, the City Charter, and City Code the City Manager prepares and submits to the Commission a budget estimate not later than three months before the end of each fiscal year; and

WHEREAS, following various workshops and public hearings the budget is adopted as an ordinance after two readings; and

WHEREAS, as the City works to finalize the budget for adoption by the City Commission various revenue and expenditure estimates are amended, line items and priorities may change and there are amendments made from the draft budget to the budget presented to the City Commission for adoption; and

WHEREAS, while City staff has always presented an overview of those changes and outlined them in the budget document, in order for the information related to employee and commission salaries to be more easily accessible to the public, the City Commission wishes to direct the City Manager to include a schedule(s) in each version of the budget presented to the City Commission that outlines the changes in salaries by department from the previous version of the budget presented to the City Commission;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.




